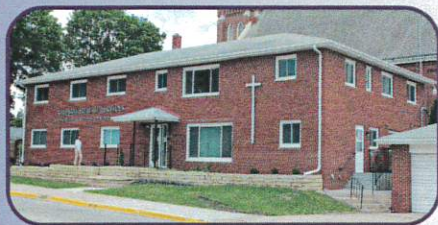


We are a state-certified mental health clinic that offers affordable counseling services to those who meet the following criteria:

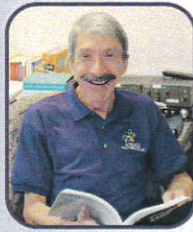

We promote a full wellness component providing children, teens and young adults with the opportunity to receive counseling services. We are able to provide a number of therapy options;

This allows us to make the client's time a positive and fruitful experience by creating an environment where they can move around, play and create things. These activities often help them open up about situations and feelings and time is spent in building trust and rapport between therapist and client.

We believe it's as important to heal the hurts of the heart as it is the physical wounds. Young clients can learn at an early age to reshape how they think and choose to act while they cope with life's challenges. In general, clients are better off after therapy than they were before therapy and better off than 80% of those not treated.



Getting a child to and from counseling appointments can be difficult. It may mean the parent has to take time off from work, resulting in the loss of much needed family income. It can also be difficult to find a counselor that accepts Forward Health/Medicaid, or that offers affordable rates for those who are not insured.

**We recognize these challenges and are here to help your child get the counseling they need. Your child's therapy sessions may be arranged to take place at a school within the Beaver Dam Unified School District, Waupun Area School District or at CHS.**
