We Too Might Walk in Newness of Life

The "click" of the lock on the casket was entirely too loud. During the height of the infection rate of COVID I was conducting a funeral for a someone whose family was quite concerned about the virus. So, the service was held in a small funeral home chapel, with very few people. Before the service started, in the utter silence of that small room, it sounded like a bomb went off when the funeral director closed the coffin and locked the lock. Family members winced at the ominous announcement of finality. Dead is dead.

We have all lived with entirely too much death for the past year. Not since the routine six-o'clock-evening-news death count of the Vietnam war, (which few of you will remember) have the American people been subject to the trauma of a daily accounting of death in our nation. COVID, though not nearly as certain as the casket, looms large in the psychological culture of our country. Now that the numbers are going down, the media, casting about for something to prolong the headlines, is offering a steady stream of remembrances of those who have died. In the face of death, the best thing this world can offer is internet memes of those who have gone on.

Not so with you. "Just as Christ was raised from the dead by the glory of the Father..." (Romans 6:4). There is a meme that is not likely to attract many clicks. Maybe dead is not dead after all. There is little doubt that the stone rolled in front of Jesus' tomb with an ominous crash. Those responsible for giving it a push surely thought, "Dead is dead." They were finally rid of the threat to their autonomy that Jesus posed. Death was their only solution, and it presented itself as promising instead of ominous.

Then came Sunday morning. There are moments when life itself is shocking. Contrary to the members of the Sanhedrin, who would have been aghast at the reports of the resurrection, the members of Jesus' little band, His disciples, were beside themselves with belief, disbelief, joy, and astonishment. Life is life! It is not supposed to overwhelm death, but, "Just as Christ was raised from the dead by the glory of the Father..."

Our shock, in the form of belief, joy, and astonishment ought be no less, all these years later. Perhaps it could be even greater, given that last year's Easter celebration was muted by the powers that be, under the fear of a menacing deadly virus. Despite all the death, and the rumors of death of the past year, Jesus is alive, and we are free to rejoice in the power of that life.

May I remind you that we do not celebrate a scientific anomaly. Easter is not academic. It is a decidedly existential event. That is to say, the resurrection of Jesus is life, for you. Allow me to quote the rest of the text, "Just as Christ was raised from the dead by the glory of the Father, we too might walk in newness of life." (Romans 6:4) The resurrection of Jesus means new life for you. The lock on the casket has been unlocked, never to be "clicked" again. The tombstone is rolled away, and you are living a new life in Jesus. No matter how ominous the sound of death in our world, life is more powerful. Alive is alive!

A Word on the Equality Act

To the Pastors, Called Workers and Members of the 6,000 Congregations of The Lutheran Church—Missouri Synod

The church's task is not political. It is the proclamation of the Gospel of free salvation in the cross and resurrection of Jesus for all (1 Cor. 1:23; John 18:36)...

Throughout history, governments have acted unjustly — sometimes in the name of race, atheism, communism, religion and even Christianity — and curtailed or denied the rights of conscience and the free exercise of religion. And governments continue to do so. Our Lutheran and biblical confession is that "it is necessary for Christians to be obedient to their rulers and laws. The only exception is when they are commanded to sin. Then they ought to obey God rather than men (Acts 5:29)" …

Religious schools (K-12 and universities) are a prime target of the Equality Act, which will make it difficult to maintain standards for admission and codes of Christian conduct for students, faculty and staff. The Equality Act will forbid college students from using federal tuition assistance at schools that maintain standards of conduct on the basis of the Bible regarding sexual orientation and gender identity....

The Equality Act was recently passed by the House and is currently pending in the Senate. The margin is razor thin. If it does not become law now, we can be assured that it will be pressed again. We encourage all LCMS people to:

- 1. Treat all people with kindness and respect ("You shall love your neighbor as yourself" Mark 12:31), while holding firmly to "the faith once delivered to the saints" (Jude 3).
- 2. Become informed about the Equality Act and the issues of gender dysphoria. (See "Additional Resources" below.)
- 3. Consider your role as Christian citizens and make your voice known to your elected officials, particularly in the U.S. House (https://doi.org/10.25/ and Senate (senate.gov/senators/index.htm).
- 4. Pray for our officials, government and the church in these challenging days.

In addition, from time to time, congregations will call me and say something like, "At the end of the year we have this budget-surplus and we would like to give it in order to bless the work of the proclamation of the Gospel in Montana. Can you help us decide how and where to give?"

That is a thrilling moment. I don't always point it out to the district, but today I want to because it is a remarkable story. A few years ago, Concordia Lutheran Church in Williston asked the Montana district for a little help getting through a financial difficulty. Now, at the end of the previous year, of all years, the COVID year, the leadership of Concordia called me and said they had some money they would like to give in order to help Montana district congregations. It was a substantial sum. God works in mysterious ways.

The rest of the story is that the congregations in Wolf Point/Plentywood/Glasgow, (triple parish) Livingston/Big Timber, (dual parish) and Anaconda were blessed by the generosity of their sister congregation in Williston. They didn't ask for the publicity. They gave from their hearts. I wanted you to know that these kinds of miracles, this kind of love, still happens.

Some of you have heard me say previously that I think the future is going to be hard for us. It is no longer popular to be Christians. We will need each other more and more. Here is another example of God watching out over us, as He grants us His generosity to deepen our bonds.

Lutheran Schools

As another compromised school year draws to a close it might be a good time to take stock of the educational welfare of our children. This past year has been difficult for teachers and students. In addition to requirements in public schools to attend to COVID restrictions, there are now added pressures to teach politically correct positions on evolution, gender identity, sexual preferences, and critical race theory. These doctrines make it very difficult for our children to maintain the Christian faith.

Most families in the Montana district do not have the opportunity to send their children to Lutheran Schools. Nonetheless, our Lutheran schools are an important tool for inculcating the faith in the next generation of believers. While not immune to the difficulties of teaching during a pandemic, our Lutheran schools are not beset with the faithless doctrines that are ever encroaching on our national consciousness. Instead, they are teaching the Word of God according to our true confession. They do it in an atmosphere carefully crafted around the love of God for us in Christ Jesus. The Gospel is the center of life. Confession and absolution are not academic, but a practice for campus life.

If at all possible, please consider sending your children to a Lutheran school. If you are home schooling you may ask the closest Lutheran school for assistance on curriculum and methodology for teaching. If your children are in public school work with the school to mitigate that which may be contrary to the faith. In addition, talk with your Pastor about how to help your child maintain the Christian faith.

If you no longer have school aged children at home, but would still like to support our Lutheran schools there are two ways you can do that in the Montana district. We maintain a <u>Lutheran Schools Fund</u> which offers annual grants directly to our schools for various needs. We also maintain a <u>Lutheran School Student Scholarship Fund</u>. This fund is accessible to our school administrators to help students who would like to attend their school but have financial needs. All of us can keep our Lutheran Schools and their teachers in our prayers.

Please also remember to keep in your prayers those faithful Christian teachers who are working in public schools. While not all the public schools in Montana are under the same pressure, these people are working hard, under difficult circumstances, to give a good witness to Christ as Lord. We need faithful Christian to work on the front-lines, striving for the best for the children in their schools. Even if we have difficulty with what may be taught in public schools, we can still support, and cherish the faithful Christians who teach in them.
