We Gather Needful Information

- 1. Roll call for attendance
 - Rick attending via telephone and Norbert was absent.
- 2. Approval of Minutes from October 2018
 - Kay makes the motion to accept the October minutes. Fred seconds the motion.
 The motion passes.
- 3. Pastor's Report
 - In sense of ministry section of report, we need to go beyond status quo. He would like to set a time for us to have a retreat to decide mission and focus of th congregation.
 - He is going to start experimenting with different worship styles to allow for silence and reflection.
 - He is also considering programs like Bible and Brews that could happen. He wants a team of people to lead these programs though, not just him.
 - We have received \$100,000 donation for the staff member.
 - If community team doesn't come together, we should scratch it. The purpose of the team is to connct members of our congregation to the community. Terri asks if we have considered a new team leader.
 - Pastor says a new team leader could happen. Terri suggests asking Brandi Painter.
 - Evangelism Team has organic approach to bringing people into the church.
 - Pastor closes by asking what he is not doing so that we could successful and wants us to consider this.

4. President's Report

- He is still doing paper work with FEMA. Also, he asked that we hold up our FEMA representative's family in prayer. His mother has not been well.
- The Endowment Board and Capital Appeal Team came together to get the bills paid. Both are being very supportive.

5. Financial Officer's Report

- Anthony needs a balance of available funds in FIRST account for Sunday report to the congregation.
- October income was down, but November might be making up for it. We are at 55% of our desired income for the month and only halfway into it.
 - Pastor adds that families with kids are busy, many are traveling, and some stopped coming while we were in the parish hall.
- After our last meeting, Rick requested money from the Lyceum and no one responded. He would like to set the expectation that costs for the Lyceum need to be paid.
- We have not received an update from Oktoberfest, but that appears to be normal until December.
 - Pastor adds that Del Papa will make a \$7,000 donation to us for Oktoberfest.
