October Church Council Meeting Minutes

We Gather as God's People

We Gather Needful Information

- 1. Roll call for attendance
 - o Rick Watkins, Albert Choate and Julie Agee absent
 - o Ron Hansen visited.
- 2. Approval of Minutes of September 2018
 - Anthony makes a motion to approve minutes, Norbert seconds. Motion passes.
- 3. Pastor's Report
 - Pastor challenges council to look beyond finances and the buildings. LEAD is Friday and Saturday and he feels we could really benefit from attending. Kay, Fred, Pastor and Terri have registered.
 - He spoke with the donor for the new staff position and they will be working toward a 200,000 goal for position.
 - Pastor poses a question about opening a line of credit through a bank. Norbert suggests finding a set amount annually to help through the summer to lessen the burden of the debt perhaps from the Capitol Appeal.
 - Rick called in at this moment, so Pastor runs these credit suggestions by him about how much the amount needs to be. For the conversation please see below at the Financial Director's Report.

4. President's Report

 He gives us a brief report on the repairs. There have been 2 change orders: the stairs to the choir loft and the ceiling in the choir room were left off the original report. The company will do the choir room for free.

5. Financial Officer's Report

- We are running at massive deficit.
- Rick suggests using an outside line of credit. Ron asks about our average needed amount monthly. Rick says it's about \$45,000 per month.
 - Pastor asks about outlying expenses. Rick replies there are interests on loans, elevator repair, seasonal electricity that we hadn't prepared for. Rick will send us all the report outlining expenses.
- He voices some thoughts on the Lyceum. He would like to ask them for a specific amount. We have received 2 \$3,000 checks from them.
 - He would like to ask them specifically for what we need, say about \$9,000. Ron suggests getting with the treasurer of the Lyceum.
 - He doesn't have accounts for LMA, so he doesn't know what's in it. But Anthony says Joe Concienne is working on it. We need to have a better overhead cost for LMA
 - 1. Ron will talk to treasurer for LMA.
 - We are not current to the Endowment Board at all. He's going to start an email dialog about cutting expenses.
 - Anthony talked to Nole about applying for the Moody Grant.
 - Discussion continues about financial imbalance. Norbert suggests cutting cleaning crew and makes a strong case. They don't cost a lot, but we are behind and he feels property board and congregation would step up.
 - 1. Norbert then brings up AirBnB discussion with the Lyceum, but Ron says it's not something they can truly do. Ron said there are great sites he'll send to Norbert.
