- 1. Sign up your nonprofit organization to participate in the program.
- Encourage potential participants to enroll, we have materials available for you to promote the program on our website at Simplygivingbythriventcu.com.
- 3. Once participants are enrolled, their electronic gifts or payments are automatically withdrawn from their checking, savings, credit card or debit card on a pre-authorized transfer date.
- 4. The funds are deposited into your organization's bank account.
