#### **PASTOR'S REPORT**

#### Reverend Riz Prakasim

Peace be with you church. We are called to look back and learn lessons from the past as we journey forward in faith. There have been occasions of celebration and lament for our family of faith. Our church, like many other churches across the nation, has been experiencing financial challenges while we faithfully live out the good news. We have been discerning the way forward with the elders of the Session and the Church Reformation Task Force who have been commissioned to explore viable options for us to survive and thrive for many years to come. Through a series of quarterly Town Hall meetings, we have been asking one another tough questions about what the future will look like. #### COMMUNICATIONS COLLABORATOR'S REPORT

#### **Communications Collaborator**

Our church's communications ministry seeks to reach the congregation and our community with messages that inform and invite participation in the church.

This year we have:

Maintained an email distribution list of around 200 addresses. These email communications via Vertical Response include:

Compiling, editing, and distributing a bi-weekly E-notes electronic newspaper.

Editing and distributing the weekly Sunday bulletin (E-Bulletin).

Editing and distributing special community announcements. These include reminders for important events, funeral announcements, and notices of closure for things like inclement weather to name a few examples.

Maintained a Facebook page with regular status updates.

Divested energy and resources away from Twitter. Our account is intact in an effort to deter scammers from posing as us, but remains wholly inactive. Considering the context of the site as a whole, it is unwise to encourage our congregants to use it.

Maintained and updated our church's website. We explored an update to our current site, but were unsuccessful due to compatibility issues concerning the new host and our @newlifechurchroseville.org emails. Ultimately the choice was made to abandon the new site and to redouble efforts to make the current site more palatable. We are now focusing on regular, prompt updates for the site to ensure relevant and timely information is available both for existing members and for newcomers.

Currently focusing on decreasing opportunities for scammers to harass our congregants by removing unnecessary/out-of-date contact information or potentially sensitive identifying information from the website/notes/newsletter, and scrubbing outgoing email lists of suspicious or bot accounts.

#### ANNUAL CONGREGATIONAL MEETING

Annual Congregational Meeting Minutes

Sunday, November 13, 2022

Meeting Announcement: "The Session of New Life Presbyterian Church has called a congregational meeting for Sunday, November 13, 2022, immediately following the worship service in the Sanctuary, to receive the Annual Report that includes church financial information. Action items include: approval of the Terms of Call for Pastor Riz Prakasim for 2023 and election of the Nominating Committee. An additional action item seeks approval for Stephen "Caleb" Njuguna, of the Kenyan Christian Outreach Church (KCOC), to pursue becoming a Commissioned Ruling Elder (CRE) through a relationship with New Life Presbyterian Church, as endorsed by the Commission on Ministry (COM) of the Presbytery of the Twin Cities Area. All active members have the privilege and responsibility of attending the meeting and of both speaking and voting. If you wish to attend virtually, please call in your vote to Roshelle in the church office before November 11th."

The call to the meeting was announced during Sunday morning worship October 30, November 6 and November 13. It was also stated in the bulletin October 30 and November 13 and distributed via email as a Community Announcement with the Annual Report. Hard copies of the Annual Report were also available at the church.

The moderator, Rev. Riz Prakasim, called the meeting to order at 11:15 in the Great Room. This was an in-person meeting. Approximately 48 active members were in attendance. A quorum was present. Pastor Riz opened the meeting with prayer.

#### **Action Items:**

Election of Nominating Committee—Chair, Pam Hord, thanked the 2022 committee members: John Bootier, Sandy McGiffin, Bruce Nelson and Jenni Mancha. She presented the names of the nominees for the 2023 committee: Barb Nelson, Judi Klotz, Adam Schultz and Pam Hord, as chair. When opened, there were no nominations from the floor or further discussion. A vote was called by the Moderator. A majority of members present voted "yes". There were no votes received prior to the meeting. APPROVED

Commissioned Ruling Elder relationship with Stephen "Caleb" Njuguna of KCOC—Pastor Riz read aloud a letter received from Brenda Alexander and Sue Goodspeed, Co-chairs of the Commission on Ministry with the PTCA endorsing KCOC's Caleb Njuguna pursuit of becoming a Commissioned Ruling Elder (CRE) through a relationship with New Life Presbyterian Church. Pastor Riz explained the concept of CRE and that it involves a series of Synod determined coursework that may be viewed as a stepping stone to seminary attendance. All across the PC-USA, churches are being served by CREs. Currently, KCOC is deemed a worshipping community working toward becoming a chartered church and this relationship will be a step toward this goal and becoming a CRE will allow Mr. Njuguna to directly provide communion to members of KCOC. Elder Spear moved to approve, 2nd Elder Hord. A vote was called by the Moderator. A majority of members present voted "yes." APPROVED.

Terms of Call—Pastor Riz recused himself from this portion of the meeting and the clerk moderated. Jan Cryer, chair of the Personnel Committee, made the following motion: "I move on behalf of the Personnel Committee with the recommendation of Session on November 8th, 2022 to approve the Terms of Call for Pastor Risley Prakasim for the period of January 1, 2023 through December 31, 2023." (A copy was distributed to all members of the congregation and is attached to these minutes.) This reflects a 3.5 increase consistent with Presbytery recommendations. 2nd Barb Nelson. The floor was opened for discussion. Given no discussion or questions, the clerk called for a vote. A majority of members present voted "yes." APPROVED. Pastor Riz was given a round of applause as a show of appreciation upon his return to the room.

**Treasurer's Report:** Jym Hubbell summarized his 19-page report printed on the green pages at the end of the Annual Report handed out to all members present and available online.

Current assets decreased by about \$146,000 secondary to: investment losses of about \$47,000; Larpenteur sign acquisition of about \$77,000; Operating Fund loss of about \$3,000 and North Como Preschool loss of about \$10,000.

Payments on our \$250,000 synod loan were covered by the Knox Legacy Fund. Loan balance at year-end was \$217,500.

The Knox Legacy Fund realized a 6% investment loss of about \$34,000.00 secondary to market volatility.

Operating Fund expenses exceeded income by \$3,074.00 which is worse than the previous year but far better than what had been projected. Operating income was better than anticipated largely due to building use fees, most significantly for Hmong funerals.

Our endowment funds decreased by \$38,000 this year secondary to market volatility during this period.

We have experienced a large loss of income secondary to multiple deaths in the largest donor demographic (ages 70 and older).

Budgeting for fiscal 2023 is a work in progress as Session strives to find solutions to declining income and increasing expenses.

Session and Finance are working on a five year plan for handling the deficit.

"Are we solvent? Yes! Are there challenges ahead? Yes!"

### **Session Member Reports on State of the Church:**

Elder Kimberly Spear—Liaison to Building and Grounds

Three session members are working with Suntide Commercial Reality for assistance with leasing the space previously occupied by North Como Preschool to another nonprofit organization. A contract is being examined and negotiations are in progress.

The Church Revitalization Task Force, whose members include Music Director Logan Combs and Rev. Greg Ritter in addition to Jym Hubble, David King, Tom Reuters and elders Sara Drake and Kim Spear is examining the need to do church differently...changing the pace... collaborating with other churches such as the current youth group/confirmation collaboration with North Presbyterian and KCOC. The Presbytery has funds available for programming.

Pastor Riz has had an initial meeting with Ace in the City, a nonprofit that specializes in property reimagining for community collaboration.

Elder Tom Carlson—Liaison to Membership and Growth

We have fertile ground to increase membership. Research shows that 50% of Ramsey County has no religious affiliation.

Some people do not visit a church because they feel that legitimate doubt is prohibited from being discussed.

Via Christian Apologetics we want to offer a place where people can learn about the Christian view on difficult topics and discuss them in small groups.

Christian Apologetics were started by Apostles Paul and Peter. They said "You must always be ready to defend your faith."

Proposing video presentations by John Lennox both online and via Adult Education presentations followed by small group discussions to increase church visibility and potential growth.

Elder Ed Galle—Liaison to Stewardship—as a charter member of North Como and New Life Church, Elder Galle recounted the changes over time from the growth in the early years of 1400 members and three Sunday morning services to the current rolls of under 200 members. He encouraged stewardship as a means to get involved in real opportunities for

change and new growth.

Question from member—have we looked into the demographic of the surround area? Other churches send out postcards. Elder Carlson responded that yes, we will do mailings as well as the use of social media.

Closing Remarks and Questions: Pastor Riz remarked that per Interim Executive Presbyter, Libby Shannon, we are in a new place. We must use our imaginations for change, combining resources and merging together. We must think creatively and uniquely. We must continue to try to understand the demographic of our community; 30% are BIPOC and 20% are seniors. Lives transformed are lives changed. Member's questions and comments included:

Much focus on Roseville. What are we doing for St Paul, our neighbors just across the street? Examples of work in St Paul includes Every Meal backpack program, Keystone Food Shelf and Foodmobile visits in the parking lot.

Concern regarding Faith Formation programming, especially for children, and concern of loss of members for better programming elsewhere. Response—on the forefront, looking at potential for staff sharing, hopefully within weeks to months to come. Will not rely on parent volunteers.

More collaboration with KCOC. Response—it is a live conversation currently being done with Youth Group and Confirmation. Nothing is off the table.

Increase Town Hall Congregational Meetings to quarterly. We need more people to get involved.

Deb Griffin moved to adjourn the meeting. Multiple 2nds. **APPROVED**. The meeting adjourned at 12:45 pm. Pastor Riz closed the meeting with prayer.

Annual Report 2023

Earlier this year, The Church Reformation Task Force (CRTF) was formed and tasked by Session to discern a viable path forward for the future of our worship community. Our name, drawn from the common Presbyterian maxim, "Once reformed, always reforming," continually reminds us of our mission to reform our worship community into one that better responds to the need of our congregation as well as our greater community.

It has become clear, with our church's growing financial deficit and decreasing membership, that our current operations cannot continue as they are indefinitely. The CRTF has been tasked with identifying and organizing the necessary changes to our worship community that will take place in the future. The CRTF continues to entertain the possibilities of merging with other local congregations, selling our property, renting and leasing the space in our building, and identifying necessary building improvements.

This last year, the CRTF has worked hard to find solutions to issues of unused and underutilized spaces of our church. The CRTF has been in talks with various pre-school organizations, in an attempt to fill our preschool space. The task force gives building tours to interested tenants, buyers and ministry partners, and is committed to securing a future for our congregation.

The CRTF holds quarterly Town Hall meetings following worship to update the congregation on our findings and also to get crucial feedback from the congregation regarding our focus and direction. The CRTF will continue working closely with Session and the Presbytery throughout this entire process.

#### **BUILDING & GROUNDS COMMITTEE ANNUAL REPORT 2022-2023**

**PURPOSE:** Building and Grounds (B&G) Committee's goal is to implement responsible management of New Life Presbyterian Church's building, grounds, and legal contracts under the authority and in collaboration with Session.

**MEMBERS:** Scott Barraclough, Chair, Earl Hoekman, Robert Jensen, Jerry Petersen, and Jan Silliman. Michelle Kozitza, Church Administrator, manages the agenda and helps coordinate committee work with vendors. Kimberley Spear is the Session Liaison and records minutes.

**MEETINGS:** The committee typically met the second Thursday of each month at 5:30pm.

**SERVICE:** Members have served for many years, providing expertise in building repair and infrastructure maintenance, technology support for internet and wi-fi, and safety support through management of fire protection and security systems. Members address emergencies 24/7 (e.g. the sewage lift pump outage, resulting in water in the lower level bathrooms and hall). Members also provide invaluable historical knowledge of construction, related systems and upgrades, and forecasting of future building and property needs. Members also volunteer countless hours in property maintenance and improvements, from plumbing, boiler issues, roof repair, window replacement and parking lot resurfacing, to lawn mowing and weeding, faucet replacement and underground water system maintenance, to landscaping upgrades and flower bed tending. Members often also volunteer to fund personally extra efforts related to property beautification, demonstrating their commitment to the people and home of New Life.

#### 2022-2023 REPORT

Highlights of the committee's completed work and ongoing efforts are below:

The committee has steadfastly continued work on fire and security systems, separating them, upgrading them, and flexing to adjust to challenges as they arose. Cameras have been installed and easier monitoring of camera footage continues to be a pending issue.

Strategic planning accelerated in 2022-2023. The Church Reformation Task Force (CRTF) started, tasked by Session to discern a viable path forward for the future of our worship community. B&G expanded in efforts to find leasees for the former preschool space, consistent with Session/CRTF charge to explore

multiple experiments. The relationship with SunTide Commercial Realty was pursued and paused with regular monthly updates to B&G and Session. Relationships with several preschools and a homeschooling academy were pursued, a couple ended, a couple ongoing. Estimates for related sprinkling systems, air conditioning, and electrical upgrades were/are managed through B&G. Related conversations about fire codes and building upgrades with the Fire Marshall and department were managed through B&G in collaboration with staff. Also, a market assessments and a formal appraisal were pursued through B&G. In summary, B&G tasks increased significantly this year as the committee responds to the strategic planning efforts of the Session and CRTF.

The committee supported the digital sign technical implementation and optimization, through efforts lead by Earl Hoekman. Earl helped set standards for the technical aspects of the messages on the sign, resolve issues with complains, draft policies and procedures for training and use of the sign, working with Roshelle Mountain, Administrative Assistant, Michelle Kozitza, Church Administrator, and Riz Prakasim, Pastor. Policies and practices for administrative uses are still in draft stage, lead by Kim Spear.

Lawn services continued with significant progress shown in grass condition and weed control. TruGreen continued as vendor. Grass overseeding with watering was started near the church main entrance this year. Drainage area was weeded with plans for a rain garden foreseen in spring 2024.

This year technology services were moved into B&G responsibilities and related dedicated funds. The digital sign oversight was moved to communication coordinator oversight.

Expenses from the committee are covered by an operating fund and dedicated funds. Operating expenses, such as utilities, continue to increase, are largely out of control of the committee, and stress the church's operating targets. Dedicated funds are used for larger expenses.

Some of the many things done this past year were the Giving/Mitten Tree project, financially supporting our missionaries, the Blue Barrel, Holy Hammers, Every Meal, the Keystone Foodshelf Truck, Blood Drives, Earth Day Sunday, the Community Garden, Quilting, the Pumpkin Patch, the Fair-Trade Market, and supporting Interfaith Action of Greater St. Paul. 2022-2023

Meetings: We did not meet on a regular basis this past year.

Purpose: We use two Earth Care Pledges originally signed by Session in 2009-10 and reaffirmed in 2014 as our guidelines. As a PC(USA) Earth Care Congregation, all areas of our church activities are committed to Earth Care Stewardship and eco justice as a part of our expression of our faith, Our Team is represented with a member on the Mission Committee and works with the Session, various committees, and individuals to support Creation Care stewardship efforts at New Life and in God's world. We are currently using the 2018 General Assembly policy called, "The Earth Is the Lord's" in partnership with "Blessed Tomorrow."

Activities: The Earth Care Team continued to provide local, organic half and half to go with the organic, fair-trade coffee that our church ordered from the Presbyterian Coffee Project. (Note: for every pound sold, 15 cents are donated to the Presbyterian Hunger Program for ecojustice, hunger-related projects.) Fellowship hour was very active due in large part to the efforts of Bob Jensen, Mike Wilson, Bruce & Barb Nelson, Andy Ihlenfeldt, and all the others who washed dishes, made coffee, brought treats, etc. Forgive us if we missed mentioning your name but know how grateful everyone has been for your service! In September we set up a special display table, at "Kick off" Sunday and served local, organic whipped cream to top people's sundaes. In October, we turned in our annual report. We also helped unload sustainably raised pumpkins that were sold to support Native American workers and our church mission trip. Both the pumpkin sale and the church garden did well (see their reports.) In November we attended the Session Earth Care Review and in December we put out an Advent Calendar.

In January we started working on our 10+ year Presbyterian Earth Care Congregation recertification report to the PC(USA) and finished in February. The certificate is hanging in the Atrium. We also heard Noelle Bakken, Roseville's Sustainability Director speak on February 5 at Adult Education about "Greening our Community" and we hope to join a local sustainability contest. On Sunday, March 19, we had a special service for World Water Day with guest speaker, Oji Roderick, the parish associate from North Presbyterian Church. Lovely goblets on the communion table held water from St. Paul, North St. Paul, Stillwater, Roseville, and the Mississippi River which was blessed during the service. Throughout Lent we posted the Earth Care Lenten Calendar which included both devotions and suggested earth care actions.

In April we used Eco Palms at church from Palm Sunday through Earth Day Sunday. On April 4th we took part in a rally at the state capitol and Governor's office to support the Prove It First law and other environmental legislation. On April 23 we celebrated Earth Day Sunday with special guest speaker J. Drake Hamilton from Fresh Energy. She spoke about how the MN legislature was moving forward for energy and climate action which would protect God's creation. The service was followed by fun activities and fellowship. Mark Rust was able to bring snow globes that showed how climate change is affecting creatures/habitat in Minnesota as well as a giant wooden "sustainable community" choice board. We had both information sheets and action items on environmental legislation like Prove It First and the Taxpayer Protection Act plus earth care pledge forms as well. We also asked people for donations to the

Presbyterian Giving Catalogue in order to get a set of 90 tree saplings to help restore God's earth. Our generous congregation raised \$120.15 which was enough for 360 trees! Thank you so much!

We also had a table for the church garden and they got a new helper to sign up. We gave away wildflower seeds, informed people about "No Mow May" for pollinators and gave out informational fliers. We also decorated the church with local sustainably raised pussy willows, branches and flowers along with our Eco Palms. A special "Thank you" to Tina Zoerb who helped in the kitchen and April Rust who made yummy little "honey bee" treats for fellowship to go with the other organic, local, and fair trade items we served.

Youth Mission Trip to Puerto Rico was June 24- July 1 and Pastor Riz said it was great especially since the group understood better what being good earth stewards meant after seeing that beautiful, tropical environment and learning that high heat levels and there effects had hardly ever been like this. Our group was inspired to do better for Earth Care and reminds us we can all do our part to be better stewards both abroad and at home.

Annual report 2022-2023

Blood drives at NLPC

In 2022, NLPC continued holding quarterly blood drives in partnership with the Red Cross. This was our second year of holding quarterly drives. As in recent years, blood supply levels were severely decreased during most of the year.

Ed Galle and Cynthia Erickson again teamed up to schedule and organize the drives. In 2022, drives were held in August and November, and in 2023, drives were held in March and May. (The March blood drive had originally been scheduled in February, but was postponed because of inability to recruit sufficient donors.) A combined total of 113 units of blood were collected during all four events, and since each unit benefits three people, a total of 339 patients were supported by these donations. Our November 2022 drive was the best we've had since 2002; we collected 32 units then.

The blood drives could not be held without our willing volunteers, most of whom also donated blood. They staffed the check in desk and the canteen over these four drives, helped potential donors check in, and kept an eye on the donors to make sure they were healthy enough to leave. The volunteers were - Alice Brotherton, Mandy Flores, Sandy McGiffin, Barb Nelson, Bruce Nelson, Virginia Redman, Gayle Stout, and Tina Zoerb, as well as Ed Galle and Cynthia Erickson. Thank you specifically to all of you volunteers for giving your time towards this endeavor.

We plan to continue holding quarterly blood drives for the foreseeable future.

#### **CHURCH FINANCE**

**Membership:** The committee is staffed by six (6) elders, preferably one (1) currently serving on session, and members of the congregation chosen by the elders and the committee. Three year terms are suggested. The Church Treasurer is a permanent non-voting member. The

Church Administrator is an ex-officio member (staff liaison) and the Pastor is a resource. Committee membership is reported to the session, with membership changes reported throughout the year as an information item. Membership of this committee at the conclusion of fiscal year 2022-2023 includes:

**General Statistics:** The Church Finance Committee generally meets on a monthly basis. This year, we typically held our meetings on the third Monday of the month from 7:00pm to 8:30pm.

During fiscal year 2022-2023, the work of the Church Finance Committee has continued to focus on managing the finances of the church post pandemic and a continued return to normalcy. We believe that New Life Presbyterian Church and this committee continue to benefit from having an experienced staff member overseeing church administration. Michelle Kozitza is a thorough and stabilizing force. There is no doubt that Michelle's experience and attention to detail helps New Life Presbyterian Church remain fiscally responsible. The committee has strived to balance risk and opportunity as we determine the investment strategy of New Life Presbyterian Church in a tight and struggling economy. Our goal is to grow the current reserves while staying true to our Christian beliefs and values.

**Purpose:** To implement responsible management of New Life Presbyterian Church's finances and legal concerns under the authority of the session.

### CHURCH FINANCE

### **Objectives:**

- 1. Maintain a working knowledge of the provisions of the Book of Order that pertain to finance and property matters. Arrange for annual audit of the church's finances, and maintain procedures in accordance with the recommendations of the church auditors.
- 2. Deposit all funds coming into the church and maintain records in accordance with the guidance of the session and the church auditors.
- 3. Facilitate and make recommendations to session regarding the annual operating budgets of all operating units of the church.
- 4. Facilitate the delegation of financial responsibilities from session to committees, staff and others, including the approval for payment of payroll and expenses in accordance with the annual operating budget and the special funds of the church.
- 5. Assist session in identifying sources for funding the short and long term financial plans.
- 6. Work closely with the Stewardship Team to quantify member contribution goals for sustaining our ministries and to coordinate stewardship activities with budget and other financial processes.
- 7. Oversee church investments.
- 8. Report regularly to the session and to the congregation regarding the status of church finances.
- 9. Negotiate insurance and other legal contracts for the church.
- 10. Acknowledge receipt of memorial funds and maintain proper records. Recommend to the session expenditure of memorial funds after consultation with the family where possible.
- 11. Facilitate the preparation of annual reports and the planning of the meeting of the congregation.

**Future Plans:** Although the Church Finance Committee's work in the coming year will pertain to carrying on the normal business of the church, we will also be working to create solutions and options to help our church deal with the decrease in revenues that is a reality of the demographics of our congregation. With this in mind, the Finance Committee will be working closely with the Church Reformation Task Force to evaluate options regarding the future of our building and land. The committee is also working with Session to determine what the role of NLPC will be with the State Fair in coming years. Will we just rent the lot to the State Fair or will we try to fully staff it in the coming year. We have also lost a couple of committee members this year, so we will be looking to recruit a new member or two over the course of the year.



Personnel Annual Report: Aug, 2022 – July, 2023

Membership: Jan Cryer (Chair), Melinda Maurey (Session Liaison), Bruce Nelson, Tom Ruter, Chuck Baumann, Pastor Riz (ex officio).

Purpose: The primary focus of the Personnel Committee is to promote a strong and nurturing faith community through a healthy work environment along with open and productive communication among pastor, staff and members of the congregation. The Committee strives for insightful problem solving and planning, is committed to open and direct communication with each other and staff and conducts thoughtful, thorough, confidential evaluations of policies, staff performance and concerns of congregation members.

#### Financial Information

Funds to support New Life's staff comprise the largest portion of Personnel's annual budget. Please refer to the Financial Report provided by Treasurer Jym Hubbell in this Annual Report for specific details.

The Personnel Committee remains hopeful that New Life will grow its financial foundation in order to maintain an appropriate staffing level based on the needs of the congregation. Stable staffing is important, both for maintaining the focus of our present ministry, programming and outreach and for the future growth of each of these areas.

#### **Review of Stated Committee Objectives**

The following constitutes the Personnel Committee's major areas of concentration:

Serve as an advocate for staff members.

Counsel staff regarding their work, goals and objectives, terms of employment and compensation.

Assist the Pastor with supervisory responsibilities and ministries, respond to members of the congregation who have concerns and evaluate staff performance.

Conduct annual performance and compensation reviews, including evaluation of goals and objectives.

Filling vacant or new staff positions, writing position descriptions, conducting interviews and reference checks and writing employment agreements.

Make budget recommendations to Session regarding staffing, salaries or pay scales for members of the church staff.

Review budget items monthly and quarterly summaries of staff vacations, sick leave and continuing education.

Evaluate position descriptions as needed.

### **PERSONNEL** (Continued)

Examine Personnel policies, research and propose additions/changes as needed and submit to Session for approval.

Perform ongoing liaison work with staff and other committees as needed, requested or expressed by staff, elders or members of the congregation.

Contact Presbytery of the Twin Cities Area for guidance as needed.

### Significant Staff-Related Events: 2022-2023

Decided to move forward with two separate positions of Director of Music and Organist/Pianist Accompanist.

August 1, 2022 hired Logan Combs as Director of Music to rebuild our adult choir and hand bell choir programs.

October 15, 2022 offered the Musical Accompanist position to pianist Emily Urban who had recently been our temporary pianist.

In late fall, Communication Collaborator Pam Schoon resigned. After consultation with both Michelle Kozitza and Roshelle Mountain, Personnel decided to replace the position instead of having the Collaborator's duties absorbed by Michelle and Roshelle who did not want to increase their weekly hours.

January 12, 2023 Justin Regier started as Communication Collaborator.

In February, 2023, Earl Hoekman started as a second Audio & Video Technician. Until this point, William Schoon had been the only weekly tech. Earl was interested in doing the job one week out of the month.

On February 27, 2023, after a lengthy series of poor custodial performance, repeated encouragement and coaching, Geoffrey Sargent was terminated as our custodian.

Justin Regier, our Communication Collaborator, expressed interest in filling the open position as Custodian. After discussion within the Personnel Committee about one person holding two paid positions on staff and an interview process, Justin was hired as our Custodian and started in late March, 2023.

After the State of Minnesota made June 19th an official holiday (Junteenth), Personnel added that day to the list of paid holidays for staff.

New this past year, and not strictly under the direction of the Personnel Committee, has been the addition of non-church member funerals or memorial services. Most of these have been for Hmong families and one was for a member of the Department of Indian Work (DIW) staff. Michelle Kozitza, with help from Roshelle Mountain and Justin Regier, has done a fantastic job of coordinating these events.

#### Staff Information

Risley (Riz) Prakasim, Pastor, provides the spiritual leadership to make the church a warm and welcoming place in which to worship. He helps guide participation in both church and community outreach activities and works closely with the youth in our church along with other related churches. Riz also collaborates with other pastors who have congregations here at NLPC and at other locations.

### **PERSONNEL** (Continued)

Michelle Kozitza, Church Business Administrator, is active in all aspects of the church's administrative and financial matters, assists with a variety of tasks and serves as a liaison with staff, committees and congregation.

Roshelle Mountain replaced retiring Deb Griffin as our new Administrative Assistant, a position which supports committee chairs, makes sure that notices and reports are correct and on time and assists members and visitors. Roshelle also creates a monthly NLPC newsletter and sends the E-Notes and monthly newsletters via US mail upon request.

Logan Combs, Director of Music, is our first music staff person in eighteen months. He brings a wealth of enthusiasm and skills to NLPC. Logan has re-built our adult choir, introduced a variety of new music in combination with favorite familiar tunes, brought in outside singers to give our choir a more robust sound and continued our hand bell choir that Cynthia Erickson had revived.

Emily Urban started as our temporary Musical Accompanist in May, 2022. After discussion with the Director of Music and within Personnel, it was decided to hire Emily as our permanent Accompanist in October, 2023. Despite not playing the organ, Emily is a very accomplished pianist and the congregation had grown to greatly appreciate her skill.

After Pamela Schoon resigned as Communication Collaborator, Justin Regier accepted the position in January. He has been working in conjunction with Roshelle Mountain to keep our congregation apprised, in a timely manner, of church news. He creates an every-other-week E-Notes and electronically disburses the E-Notes and monthly newsletters along with updating entries to our Website and Facebook pages.

Justin Regier took on our Custodian position when it became available in March. He is tasked with keeping our building a clean and safe environment in which to worship and participate in church activities.

The Audio/Visual Tech position has been skillfully provided by William Schoon since February, 2021 and more recently, on one Sunday per month by Earl Hoekman.

Dustin (Bean) McDonough has been filling in as necessary as our Custodian.

The Personnel Committee continues to be appreciative of each of our staff. We hope and pray that, as a congregation, we can build on our strengths to increase participation in all aspects of our life together and encourage membership growth.

**PURPOSE:** The Stewardship Committee is responsible to continually and creatively invite the members of our church to contribute financially as responsible and grateful stewards of God's gifts.

**ACTIVITY:** Our church's attendance has rebounded slightly from the effects of the pandemic, but we are not experiencing the regrowth we hoped for. We're 'small but mighty', but still small. Our Session has appointed a task force to look at options for alternative building uses or mergers with other churches.

Early in 2023, our members contributed more than \$4000 toward our "per capita" goal of \$7650 (this is the amount we pay for Presbytery operations). That \$4000 is now available to help pay New Life's operating costs and we appreciate all the folks that were able to contribute.

In early July, the Committee began the Stewardship Campaign with a letter to each member of the congregation (140 giving units). The letter was personalized and handaddressed. We emphasized the need to support our church strongly during this time of transition, and announced a Matching Gift opportunity that will match any gift which exceeds what the member gave last year.

Results of the Campaign so far: Commitments received for 2023-24 = \$134,580. In addition, there are several donors who use Vanco for electronic giving but do not pledge. Their giving amounts to an extra \$65,390 annually. Our contributory base continues to decrease due to deaths, which puts an extra burden on our remaining faithful givers. As always, we thank you for all your help.
