- I. Bi-Annual Council Retreat Saturday, January 4th 8:30AM ½ day. Hendricks house including breakfast.
- II. Review of Church Use Policy table to next meeting.
- III. New computer For AV room Pastor Kevin Richter will email Paul Hendricks in consultation with Scott Schulz to make this purchase.
- IV. Director of Parish Music and Director of Christian Education intern position.
 - A. Pastor Tim Ludwig and Ruth Woltmann presented the Compensation Decision Support Tool results from the LCMS website that shows the appropriate range of pay for a Director of Parish Music.
 - B. They have researched the idea of sponsoring an internship for a director of parish music if such a program exists. There are only about 10 students within the LCMS that would potentially participate in an internship. (Internships are not required of these students.) An intern would cost significantly less than a full time called DPM.
 - C. The total benefit package for a full-time DPM would range from \$61,333 to \$72,581. Depending upon experience and size of family.
 - D. They have also explored the idea of sponsoring a Director of Christian Education intern for 12 months. Ruth Woltmann proposes that this intern would be fully responsible for the youth part of her duties. Churches seeking a DCE Intern must apply by February 1, 2020. The intern would start in June, July, or August.
 - E. We will publicize the idea of potential DCE intern and DPM within the next two weeks to begin the discussion and to get feedback from the congregation. We will schedule a forum on November 14th at 5:30 with a light supper to give the congregation an opportunity to ask questions and give feedback. Grant Forsyth will facilitate this meeting.
- V. 2020 Budget / Voter's Meeting
 - A. Council chairs must get their budget sheets to Liz Shannon by November 14th.
