#### F. Missions

- a. The DiLiberto's have taken a call to Henderson Nevada. We are questioning if we stick to the other family recommended in Puerto Rico or locate missionaries in another area. We have sent the original \$2000 donation to them in Puerto Rico. We have previously approved \$2500 for further mission donations. We will wait for more information before deciding where to send the donations.
- b. Mission trip information meeting for the congregation will be held September 29<sup>th</sup> at 6PM by Jerry B. The trip would potentially happen sometime November -March of 2021 or 2022.
- c. Jerry has been in communication with Mission Central about setting up a mission trip when it is safe to travel.
- d. Finances
  - i. \$5,000 was given this year
  - ii. We will budget an additional \$2000 for next year
- e. Going forward:
  - Look into other locations as the other family in Puerto Rico is fully funded.
  - ii. Support a family? Individuals?
- f. 7-8 people will be going on a Derecho Relief trip to Cedar Rapids King of Kings Lutheran Church in Iowa on August 23-26. They are bringing a van load of donations. This trip will involve a lot of tree clean-up.

- F. A new Health Insurance Policy has been written. The church will pay 60% of the cost of health insurance for any called workers and full time employees. PIC will reimburse workers that choose to be on their spouses plan at 60%. Jordan Urshan reviewed the cost effectiveness of the health insurance plan and carrier that we have been using. We will switch to a high deductible/HSA plan for the church.
