Ad Hoc Finance Committee Report

Lisa Baker

- Endowment fund: \$150,000 has been given to the church as a gift. Is this something that the church council supports? If Yes, there are documents available
- Motion: Pam made a motion to create an endowment fund, Julie seconded. Unanimous vote.
- Council NEEDS to: individually email Lisa with questions or feedback on endowment proposal and spending procedure
 - Endowment proposal: purpose, duration, governing body, fund administration, and donation guide
 - Endowment spending procedure: We would only spend the interest each year,
 not the principal. This will allow the fund to be
 - Members of committee
 - 5% spending of the interest
 - Investment account/policy statement: Northshore would manage 50% stock, 50% bond. We would give a range not necessarily
 - December 31st would look at what we have in interest to spend in the next year.
 - How would council like the amount like 5%: Examples 1% for youth, 1% charitable organization, etc.

- A. Union Gospel Mission Mailing
 - 1. 65,000 letters this year, we completed 45,000 last year in less than a week
 - 2. Kicking off the event on Sunday, October 18th (MEA weekend) between services. Each round table will be set up for congregation to stuff letters
 - 3. Tables will stay set up in the fellowship hall for individuals/ families to come stuff letters throughout the week of October 19- 23rd. After this week we will assess where we are with the project and make additional plans depending on how much we have completed.
 - 4. Reached out to key individuals who have assisted with this project in the past and served as contact people during the event to allow them to take items home to stuff. This group is working on our first 20,000 letters that were delivered.
 - a) This option will **not** be opened to the whole congregation due to tracking, receiving items back in a timely manner and the timeline of completing the project.
 - b) 5,950 completed right now. 7,000 left here at church, the rest being stuffed.

 - A. Motion: Pam made the motion to accept the bid from Citon for what's listed on the quote for AEGIS, Patching, AVAR, Firewall and QNAP with Backblaze, as well as include the \$5,000 block agreement. Dauli seconded this motion. Vote passes unanimously.
