Rules & Regulations

1. Teams can consist of up to 4 players
2. Double Elimination Tournament
3. Coin toss determines first possession
4. 10 baskets or 15 minutes, each basket counts as 1 point
5. No timeouts
6. Must win by 2 baskets during regulation time
7. Game tied at end of regulation goes into Sudden Death, possession determined by coin toss
8. When shooter is fouled, shoot 1 free throw, if free throw missed, shooting team keeps possession of ball
9. If the court official rules a foul was flagrant or meant to cause harm, the player fouled will shoot 1 free throw and keep possession of the ball. The player called for the foul will be warned once, if that player is called for any flagrant foul thereafter, he/she will, be ejected from that game.
10. Anyone involved in fighting or continuous misconduct will be disqualified for the remainder of the tournament. **NO EXCEPTIONS!**
11. Check ball at top of key after each basket made, followed by a pass.
12. Take ball past free throw like everyone on change of possession.
13. No hanging on the rim or dunking, 2 points awarded to opponents.
14. No swearing or cursing. Good sportsmanship is a must!
15. If you have an ineligible player, your team will forfeit all games already played with that player.
16. Defensive team gets possession of jump ball.
17. No unauthorized people on the court.
18. Any team forfeiting the tournament will lose their entry fee and shirts.

Assumption of Risk, Release and Waiver Form

I am aware that participating in the St. John's Lutheran Church 3-on-3 basketball tournament can be a dangerous activity involving many risks of injury. I understand that the dangers and risks of participating in the above event include, but are not limited to, death, serious neck and spinal injuries which may result in complete or partial paralysis, brain damage, serious injury to virtually all bones, joints, ligaments, muscles, tendons, and other aspects of the musculoskeletal system, aggravation of underlying diseases which could result in illness such as heart attack or stroke, and serious injury or impairment of other aspects of my body, general health and wellbeing. I understand that the dangers and risk of participating in the above event may result not only in serious injury, but in a serious impairment of my future abilities to earn a living, to engage in other business, social and recreational activities, and generally to enjoy living.

Because of the dangers of participation in the above events, I recognize the importance of following rules and regulations established by the St. John's Lutheran 3-on-3 Basketball Tournament Committee and agree to obey such instructions. I acknowledge that I am in good physical condition and do not know of any condition or reason that I should not be able to participate in the 3-on-3. I recognize and acknowledge that the St. John's Lutheran Church does NOT carry special health insurance that would provide such special insurance coverage for me in the event I should sustain injury while participating in the 3-on-3 basketball tournament.

I understand that risks involved in this activity and I am voluntarily participating in the 3-on-3 basketball tournament. By my signature below, I hereby recognize and assume to release and hold harmless the St. John's Lutheran 3-on-3 basketball committee and church, its volunteers and all those associated with both committees harmless from any and all obligations, liabilities, claims, demands, expenses and costs, including attorney's fees or demands of any kind and nature whatsoever which may arise by or in connection with my participation in any activities relates to the event of the St. John's Lutheran 3-on-3 basketball tournament. The terms hereof serve forever as a release and assumption of risk for my heirs, estate, executor, administrator, assignees, and for all member of my family.

I hereby authorize St. John's Lutheran Church to publish photographs taken during the 3 on 3 tournament of myself and/or the minor child or children listed below, for use on the St. John's Lutheran Church website, Facebook page, publication, promotion, illustration, advertising, in any manner or in any medium.

I hereby release and hold harmless St. John's Lutheran Church from any reasonable expectation of privacy or confidentiality for myself and for the minor child and children listed below associated with the images specified above.
