



Tuition Assistance Information and Guidelines

1. Families should first apply to the Wisconsin Parental Choice Program. The Tuition Assistance form is to be completed and returned to the Principal of St. John's, with a copy of your **most recent** completed Federal Return 1040 Form.
2. Filing Deadline: All applications for tuition assistance should be on file by June 30, preceding the school year of attendance. The Administration reviews applications on a regular basis and there is only a set amount of money to be given out. It is on a first-come-first-serve basis and when the designated dollar amount is gone, there will be no more financial aide given for the remainder of the school year; therefore, there is no guarantee that assistance can be provided.
3. All information is confidential and will be reviewed only by the Administration.
4. The Administration of St. John's Lutheran Church and School does not discriminate based on race, color, or national or ethnic origin to all the rights, privileges, programs, and activities generally accorded or made available to students at the church.
