# The 40 Days of Easter

- · Clear Details, Assumptions, and Things Unspoken


#### Pulling it Together

#### We're Trying Something Different for Church Yard Clean Up





# Parish Planning Council Special Meeting COVID-19 - Payroll Protection Program, April 5, 2020

Meeting via goggle meet – in attendance – Pastor Neubauer, Pastor Newton, Jerry Grudem, Rod Helm, Ginny Ranisate, Shirley Potter, Mike Poole, Brad Dahn, Connie Fondow, Brandi Backmann, Lori Griess, Elayne Luiken and Pam Heeren. Kathy Henry was asked to join later in the meeting

Call to Order --Rod Helm, Executive Director. Opened with prayer- Pastor Neubauer. Rod reviewed some of the information from the meeting in March.

The purpose of the meeting was to discuss whether St. John's Lutheran Church should apply for the Paycheck Protection Program ("PPP") grant/loan at this time. The loan/grant is to be used towards Salaries, retirement, utilities ---Available April 3rd --- Synod suggest that we participate in the program Low interest loan --- Kathy Henry called Pastor Neubaurer to let him know that the program was available and thought we should look into it.

Online giving is up. Ginny thinks we are better than most business. March is down but not excessively from last year.

The question is ---if we want to participate in the government program. The unknown --- this would take a vote from the voters – but can't due to the stay at home order. 1% interest – must be paid back in 24 months --- 6 months are deferred – so actually 18 months if we defer monthly payments for 6 months. You can apply until June 30th. Of course, it is unknown whether the monies will run out if we wait.

Each director was called on to give their option, concerns, suggestions and questions on how to come to a decision regarding the financial stability of the congregation and whether the Payroll Protection Program was something we should apply for.

Below is a list of concerns/questions/remarks

if it is a loan or possibly a grant -- we are taking on cost that we should not have to bear. We are on our own. I don't see taking on a loan

there will be questions from members either way – why did we take the loan --- or why didn't we apply for the loan. We (the PPC) are the branch of the congregation that makes the decision. Continue to trust the Lord

we should use what we have .... not take out the loan

the hospital board meeting – Hubbard County is very aware – 6—8 weeks is when they think our big jump in COVID-19 ---

have taken out a SBA -loan-- not a fun process --- SBA has more power than Banks --- if you pay it off early you may not have a penalty but you may not get the same interest that you received at the start of the loan -so really there is a penalty

I am on the fence --- how many members won't be able to continue giving at the same rate.

Hearing some distrust in government

synod and district are going to apply

synod lawyers have reviewed the application - they said go for it

hesitant to how it is worded

should the elders be involved in this decision?

Do we need the loan to cover expenses? If we don't....don't apply

Google form is a way to vote -

trust is a challenging thing --- either way gambling with or without money from loan/grant. google forms – anonymous vote

There is no revelation for this --- we had a good discussion. Prayerful consideration to do this or not. Not clear on vote with congregation --- long term good of the congregation. Above all we trust in God to provide. not a bad idea to apply for grant/loan

we are not unified enough so we need to meet again.

Kathy Henry joined the meeting – the "PPP" is a program to keep people employed...the loan is forgiven when you prove that monies went to the appropriate expense (salaries, health benefits, utilities i.e.) and that you sustained your employees. This loan program is from the local bank not SBA— the monies are guaranteed by the government/SBA to the banks.

There are worksheets available to walk through the loan process and to better understand -- -Kathy will email to Rod --- interest rate 1% - must be paid in 18 months after a 6-month deferred payment. The timeline to receive the monies is relatively fast once the application is approved. No payback unless you don't keep employees.

Jerry will have a conversation with the Elders, so they are aware of what has been discussed regarding the PPP.

April 14th meet again Tues --- 6:30 pm

Kathy suggested that Ginny prepare a projected budget for the next 6 months, based on current expenses and if income stays the same as March 2020. Then the PPC can have a visual as to what could happen financially if we do not apply for the loan.

Since there was a lot of discussion and very good questions, concerns and information to think about, it was decided to postpone a vote on the issue and meet Tuesday, April 14th --- 6:30 pm.

Pastor Neubauer --- thanked the PPC for a good meeting with difficult decisions to make— and that he has been blessed with this congregation.



#### What you need:

- Needle and string
- 12 small pom-poms • Coffee filter
- Wooden craft stick
- Scissors
- Googly eyes Glue
- Markers

#### What you do:

- 1. Sew pom-poms together to make a caterpillar body. Tie off that string.
- 2. Thread another string up through the first pompom, leaving 12 inches to dangle. Repeat with the ninth pom-pom, leaving two dangling strings.
- 3. Wrap those strings around opposite ends of the stick, adjusting their length to about 6 inches. Tie in place.
- 4. Glue on eyes.
- 5. Flatten the coffee filter and draw a symmetrical design on it. Pleat in the center to create wings.
- 6. Move the caterpillar puppet by holding the stick. Glue on the wings as you describe the transformation into a butterfly.



#### PPC Special Meeting - April 7, 2020

Call meeting to order Rod Helm. Present via google meeting: Pastor Neubauer, Pastor Newton, Jerry Grudem, Rod Helm, Shirley Potter, Mike Poole, Brad Dahn, Connie Fondow, Brandi Backmann, Lori Griess, Elayne Luiken and Pam Heeren. Call to Order --Rod Helm, Executive Director. Opened with prayer- Pastor Neubauer

Shirley read minutes from April 5, 2020 - special meeting. Jerry Grudem - motion to accept minutes as read. Brad Dahn second. Motion Carried

Pastor Neubauer contacted Rod after a sleepless Sunday night and said that he felt we should act sooner than later. Recommending to apply for the loan at \$40,000.

Connie asked that Jerry speak to the issue that you don't want to take a lesser loan than what was available. Jerry stated --Can't imagine not taking out the loan for the maximum amount to cover payroll for the next 8 weeks. This is an application for a grant --- no cost to us --- -not applying for a loan. Connie --- if we adhere to the policy of the grant – feels we won't be paying anything --- it will be a grant. Jerry ---we are applying for grant- We (all US taxpayers) will be paying it back through our taxes not as a loan payment. We have concluded that there is no strings attached. Connie – it becomes an insurance policy. Use it if we need it.

Our monthly operating expenses are approximately \$33,000.

Pastor spoke on how he arrived at the \$40,000 --- thinking we could use the Healthy Balance to cover the other \$30,000. Another reason why not to take the full amount -- We shouldn't take any more than we need --- as we don't want to take away from anyone else applying. Only 10% of operating budget of the year. This is a onetime application – The govt may re-evaluate and offer more funds

Rod – I am not recommending being reckless – but I am for the grant. Connie is for it --- but is uncomfortable. There was much discussion in regard to calling the PPP a "loan" or a "grant". It was the understanding of all the we will receive the loan, and that the loan would be forgiven. So therefore, a grant. Pastor Neubauer spoke regarding the Constitution of the Church

**Connie made the motion.** In light of the government restriction regarding meeting in groups of any size due to the Coronavirus Pandemic, we, the members of the Parish Planning Council of St. John's Lutheran Church, Park Rapids, MN authorizes Dr. Rod Helm to sign the application for a loan offered by the United States government to provide financial assistance to maintain employees and operating expenses. The amount of the loan requested would be \$60,000- plus or minus \$5,000 -initiated at Citizens National Bank under the Paycheck Protection Program in cooperation with the Small Business Administration. Second Lori Griess

Rod asked if there was any more discussion – no further discussion. Roll call vote – unanimous – motion carried Mike Poole, Jerry Grudem, Brad Dahn, Elayne Luiken, Brandi Backmann, Lori Griess, Connie Fondow, Pam Heeren, Rod Helm

To the voters, please know that this was not a decision that we the PPC made without much discussion and consideration.

Pastor Neubauer had made calls to brother-in-law in Wisconsin and the Church in Walker. They are both applying for this loan. The Synod and District are recommending apply for the loan

In the quandary we are in, this was a very difficult decision for all the PPC members in this extraordinary time. Much

discussion was had regarding whether we would regret our decision and how the voters would react to our decision. Also, because of the uncertainty of how much the coronavirus will affect our members contributions.

Rod Helm will sign the loan application at Citizens National Bank as Executive Director of the church --- it was suggested that Brad Dahn and Randy Griess will sign for the church as trustees, Church Properties --per the Church Constitution.

Rod --- thank you all this was a difficult decision

Motion by Lori Griess second by Jerry Grudem to adjourn. Meeting Adjourned

#### Old/New Business

Pastor Neubauer – shared concerns regarding Mike Riewer. Mike was unsure what was expected of him. Mike feels he may be breaking the law if he cleas. Hasn't been in for 3 weeks. Mike did come in today and do general cleaning. Pastor wanted clarification of the conversation between Mike and Brad. Brad - Spoke to Mike Friday or Saturday ---Brad asked him if he could come in maybe Monday to clean as there was a need and no one would be there as the office was closed. Mike did tell Brad that he had no intentions of leaving the job and that he enjoyed the work. Jerry – no details as to whether this is or is not breaking law.

Rod informed us that we have been approved for the loan – and will be signing the papers tomorrow.

Clarification on who is paid --- all employees working prior to the COVID pandemic social distancing and Shelter in Place order, are to be paid as if they are working, that is the purpose of the loan. With one exception, Elayne Luiken was planning to retire at the end of the school year. However, since the shutdown she retired in Mid-March.

Ginny says we should be able to meet the \$60,000 in 2 months. The loan can be used for ---Utilities 25% --- Salary 75%

Next meeting was set for April 28th 6:30 pm.

Brad Dahn updated us on the canopy repair--- Bernie Gartner will be doing the repair. Brad and Bernie will be meeting with a structural engineer this week. Pastor Neubauer --- we have talked about expanding the front entry --- do we have to repair the canopy now? Brad says we need to do something for safety issues but will not know the extent of the repair until after the meeting with the engineer. The insurance company will be sending us a check for \$17,000 initially and if the exact cost is more, they will send another payment for the entire cost.

Pastor Newton closed with devotion.
