Attendees: Carol, Beth, Christy, Pastor, Kristina, Nancy, Fred, Erin, Nicole, Steve Guest: Doug Oberbroeckling from Cunningham Recreation via Zoom

Presentation of quote for replacement decks (emailed August 30, 2022, to Christy Petersen).

- 15-year warrantee on quoted materials, even if we install ourselves.
- Approximately 8–10-week lead time: get order in by March 2023 for summer 2023 installation.
- Sales and 2023 pricing provided.
- Referred us to company website: Gametime.com for additional browsing
- New quote requested for all new structures, under \$20,000.

Discussion of Minutes

- Motion by Nicole: pursue gametime Fontana set at \$10, 182, with request for funding for \$5,000 from the church, \$3,500 in fundraising through 2022-2023 school year, and \$1,000 from general fund; 2nd Nancy.
 - Further discussion leads us to reject motion without a vote; immediate purchase is fiscally irresponsible.
- Postpone purchase until next spring while we apply for \$16,000 of NID grant funds.
 - o Additional research Kristina (GameTime) and Nicole (outside GameTime) to look for playground models to propose on NID grant application.
 - Consider reaching out to legacy families

Current status:

- o Little Saints has already spent \$2500.
- New posts and wave runner are installed and functional, but paint/coating is deteriorating, amounting to a cosmetic flaw that will cause more damage eventually.
- Discussion: playground repairs and replacement
 - Current funds: donations and surplus money (\$9000+)
 - o Buying now: "Just do it."
 - \$10,000 for total replacement if we buy at sale price by October 31, 2022;
 - Spending \$9000, exhausts all reserve funds (non-operating funds);
 - Unattractive financing through GameTime;
 - Ask the church for \$5,000 on top of obligatory \$10,000-line item;
 - Anticipated fundraising (\$2000 x twice yearly).
 - o Additional funding, whether replenishing reserves or earning funds prior to purchase
 - Is April NID grant decision retroactive? Pastor to ask. If so, it would replenish
 - Ask for donations;
 - Legacy fundraiser
 - o Order in March for summer 2023 installation (or postpone even later)
 - Look for additional companies
 - GameTime
 - o Anticipation of increased salary costs over the next year and of November conversation:
 - Teacher-Director, Teacher-Assistant = 2-pay system for every staff member, plus raises built into tuition
 - Grant opportunities are limited. Next NID grant application is due in April 2023.
