Does God Care about The Body?

esus said to her, "I am the resurrection and the life. Whoever believes in me, though he die, yet shall he live, and everyone who lives and believes in me shall never die. Do you believe this?" (John 11:25-26)

The parents stood next to their son with a heavy heart. They were filled with concern (it was out of their control), with apprehension (not knowing what to expect), and with a tinge of fear (what did the future hold). Tomorrow their boy would be undergoing major surgery. Without the operation, a slip of the foot, a jarring of the head, or one wrong twist and their son could be paralyzed at best—or lose his life at worst.

God loved their son, but it is so hard when it is one of your children. Christ went to the cross. Spiritually their son would be fine, but does God care about what happens to the body?

Was Jesus not conceived in the body, born in the body and lived in the body? Did He not suffer in the body? Was He not crucified, died and buried in the body? His resurrection and ascension were in the body. He promises that in the body He reigns at the right hand of God and will return to judge the living and the dead in the flesh. Does God care about what happens to the body?

Alleluia!

Did not God create your body? Knit you together in your mother's womb? Did not God baptize His body? Will He not raise your body so that before your own eyes you will see God on the last day? Does God care about what happens to the body?

Alleluia! Christ is risen.

I stood with the family and gave to them the body and blood of Christ into their bodies! Yes, Jesus cares about the body.

Alleluia! Christ is risen. He is risen indeed.

The Hebrew word in the Old Testament for soul (Nephesh) doesn't simply mean spirit, but it means the whole of you. So when God redeems your soul, He is redeeming your spirit, mind, and body. Healing may or may not occur while we are here on earth, but God did promise perfect healing at the resurrection. Yes, Jesus cares about your body, your mind, and your spirit.



As Dad so often said throughout those almost eleven painful years of adjustment after Mom's death: "Thank You, Lord Jesus, for giving us the victory!" We are comforted in our sorrow, and through our tears we look with certain hope to the resurrection of the body and a happy reunion in heaven with those we love who have died in the faith. "Thank You, Lord Jesus" indeed!

As a congregation you face a future that is unknown, and even as our own lives as a family must now adjust, so also the congregational family at Trinity must adjust. You are all in our prayers as you continue to be the people of God in this place, in His hands of care. Because of God's promise to *His* church, you are able to pray that prayer which Dad shared so often, and which we ourselves were given occasion to pray these past months: "Thank You, dear Lord Jesus, for what You have done and what You continue to do through this congregational family at Trinity, Columbia!"

MARCH 13, 2018 BOARD OF DIRECTORS MINUTES (Draft Minutes, Vet to be Approved)

(Draft Minutes - Yet to be Approved)

The regular monthly meeting of the Board of Directors was called to order on March 13, 2018 at 7:05 p.m. Attendees included Gary Kespohl (Chairman), Jacque Eckhoff (Secretary), Carol Morrison, Roger Morrison, Mary Frerking, Pastor Brian Thieme, Kali Weishaar, Andrew Saeger, Chris Bailey, Tammy Mangold, Ken Greer, Virginia Propp, JoAnn Schoenike, Doug McDowell, Annette Kiehne, Doug Kiehne and Warren Harms.

Pastor Thieme gave the opening devotion.

Chairman Kespohl added two items to New Business. Item one is Pastoral Support Pay and item two is Scholarship Payment. He then added Phil Glenn to the beginning of the Meeting Agenda. Pastor Thieme noted he had a handout listing new membership changes to go with his report. Roger Morrison moved to accept the Meeting Agenda with these changes; seconded and approved.

Jesse Bray, with GFI Digital, spoke to the Board of Directors about a copier service/maintenance bid. He stated that GFI is a Missouri based copier company, and actually the only one left. He noted some of their current clients include LCMS in St. Louis and Alive in Christ Lutheran Church in Columbia. His proposal was for three brand new copiers, and he suggested a Manage Print Program that has a 60 month term. Under this program, every 48 months you get a new fleet of copiers. He stated that you save money over time. Some perks he mentioned of going with GFI are as follows: technicians completely clean and look the machine over on service calls, and they are the only company offering free IT support on copiers Pricing...with GFI it's cost per copy, meaning you only pay for what you use. The price would be \$374.30/ month, which is \$22,550 total for 60 months. But remember you are getting new copiers at 48 months. Maintenance ONLY will increase 10% per year. He ended by saying GFI keeps 98% of their customers, and the bid will be good until the end of month. Discussion continued after Mr. Bray left. One point made is that current copiers are not that old, and still functioning at an efficient level. Warren Harms moved to discuss the copiers again in a year; seconded and approved.

Phil Glenn spoke to the Board of Directors about the SCOTUS Ruling and its current status. He began by reviewing the situation and where we are at

this point. He then reiterated that as part of the settlement the State said they would accept our old application for a new grant year. If we want the rubber product we will need to reapply At this point, the earliest we could reapply is 2019. Phil stated that nothing has been signed, and cautioned that we should allow the attorneys to negotiate the settlement.

Andrew Saeger moved to accept the Consent Agenda; seconded and approved.

MINUTES OF FEBRUARY 13, 2018 MEETING

Chairman Kespohl stated that under New Business the radio station should be corrected to KFUO. Also under New Business, the Facility Use Request for McDowell Graduation Party should be changed to May 26, 2018, 1:00-8:00 PM. Mary Frerking moved to accept the Minutes of the February 13, 2018 Board of Directors Meeting with these changes; seconded and approved.

The Consent Agenda meeting minutes and reports are filed in the Congregation Secretary's notebook. The following are summaries of the reports, with the name of the board representative at the Board of Directors meeting listed:

ASSOCIATE PASTOR - Pastor Thieme

Pastor Thieme has taken JCC III and John Frerking has taken JCC II. JCC III are preparing for their presentations. May 5th in the morning is practice and pictures for Confirmation. May 5th in the evening they will give their presentations. May 6th is Confirmation in the 10:30 Service.

Adult Classes: There are four couples going through premarital classes, Sunday morning we are going through I Peter, the Monday morning class is going through the Large Catechism, and the Monday evening class is going through a series on reconciliation.

Pastoral visits continue to be made with individuals, couples and families. Trinity has a plethora of meetings to attend. The DCEI has only 4 months before she returns to the university setting and gets married.

DIR. OF CHRISTIAN EDUCATION INTERN - Kali Weishaar

Taught 6-8th Grade Religion February 19-23, assisting with planning VBS and leading short Ladies Lenten Bible Study on Wednesdays. Leading Sr. Youth on Sunday mornings, building relationships with Shepherd's Kids through baking and storytelling, and planning Sr. High Lock-In.

FINANCIAL SECRET'ARY - JoAnn Schoenike (Financial Secretary)

For the month of February, the Regular Envelope collections are 96.09% of the anticipated monthly amount. Loose Plate collections are 178.64% and Sunday School are 78.73%. The Total Monthly collections are 99.14% of the monthly anticipated amount.

BOARD REPORTS:

CHRISTIAN EDUCATION - Mary Frerking

For the next two Sundays, the Sunday School kids will participate in presenting a Passion story play and an Empty Tomb play for the Adult Bible Study members.

On Palm Sunday the children will process into the church with palms during both services, and will sing with the choir at the 10:30 service. On Easter Sunday there will be the yearly egg hunt, the story of the Resurrections and an Easter craft. The BOCE will take over responsibility for the summer Sunday School lessons. This summer's VBS will run from July 10-13th in the evenings from 5:30-8:00 PM. Dinner will be provided each evening. The BOCE is planning to make a thorough review of all their materials stored in the Sunday School closet. They are also planning to prepare a yearly calendar of tasks/activities to make it easier to transition each year and assist new members joining the board.

EARLY CHILDHOOD EDUCATION - Virginia Propp

100% Enrollment. Summer 2018 Enrollment is on track for seven toddler/preschool/preK/school age classes. Fall/Spring 2018-19 Enrollment is operating a waiting list to optimize final open spots. Two toddler spots and three T/Th preschool/preK spots yet to be filled with many on waiting lists to be turned away. Approval from AOV to purchase Creative Curriculum. Purchase will be made in March. License renewal will be required in July 2018. Freezer and refrigerator installed and has increased the efficiency of the kitchen. Phyllis White has been conducting chapel on Thursdays.

ELDERS - Doug Kiehne

The Elders met on February 27, 2018. Discussion was held with regard to the calendar for the last six months of 2018. Also discussed were short term options to help with Pastoral needs. First, the Board gave approval for Pastor Thieme to schedule someone to preach once a month. Also he will bring forth names of a person to visit shut-ins 20-30 hours a month. The Board is requesting a bulletin board space dedicated for keeping the congregation informed about the Call Process. They discussed the Call Process and next

steps. A ministry description is needed and the options presented by President Hagen on how to proceed were discussed.

EVANGELISM - Doug McDowell

The Board of Evangelism met February 21, 2018. Doug McDowell volunteered to be the Chairman of the BOE. Items discussed were Social Media as an Outreach Opportunity, Missouri District "Plus-One" Initiative, Christianity 101, and TLC at TLC.

PAROCHIAL EDUCATION - No Representative Present.

SOCIAL MINISTRY - Carol Morrison

Final report of Souper Bowl of Caring benefiting the Food Bank showed 134 pounds of food collected. The total free-will donations collected were \$204.00. There was one Member Assist request in February through Pastor Thieme. Social Ministry will help with the Pancake Breakfast and Blood Drive.

STEWARDSHIP AND FINANCE - Andrew Saeger

During the month the Board of Stewardship and Finance held on-line meetings to plan for the Lenten Light Supper. The Board served soup and sandwiches along with dessert on February 28th. The offering count continued during the month per the agreed upon schedule.

TRINITY LUTHERAN CHURCH ENDOWMENT FUND - No Representative Present.

COMMITTEE REPORTS:

EXECUTIVE COMMITTEE - No report filed.

MEMBERSHIP CHANGES:

Pastor Thieme did an overview of the current Membership Changes. Virginia Propp moved to accept the changes; seconded and approved.

TREASURER'S REPORT - Warren Harms (Treasurer):

For the month ending February 28, 2018, the Church income is \$46,455, and year to date is \$90,770 (14.9% of the total income budgeted for the year).

The total Learning Center income for this period is \$62,821 for February and \$135,738 for the

year to date (20.0% of the budgeted income for the year).

For the month of February, 2018, Church expenditures are \$42,417, and \$92,196 year to date (15.1% of the annual expenditure budget of \$609,775).

The Learning Center expenditures for February 2018 total \$48,113 and \$89,147 year to date (13.2% of the annual expenditure budget of \$677,900).

Total income for the first two months of 2018 is \$226,508 which is 17.6% of the annual budget. Total expenses for the first two months of 2018 is \$181,342 which is 14.1% of the annual budget.

The invoice from Septagon Construction for the gymnasium ceiling repair and new LED lighting was paid in February at a total of \$27,212. The total project was expensed in 2017 as the project was actually completed the last week of December. The new refrigerator and freezer in the educational wing kitchen were installed in February and are in use. The estimated cost of \$4,330 was also expensed in 2017 when they were ordered. No invoice has been received as of the end of February.

Net operating cash as of February 28, 2018 is \$241,763. Cash in our dedicated accounts totaled \$91,583.

Per the AOV approval at the February meeting, \$35,000 was sent to the 197-TLCLC Reserve account at Lutheran Church Extension Fund. We were able to send this to the savings account from the surplus the Learning Center was blessed with in 2017. The total of the reserve accounts at LCEF on February 28, 2018 is \$106,706, Andrew Saeger moved to approve the Treasurer's Report; seconded and approved.

OLD BUSINESS:

SCOTUS Ruling Reconciliation Update

Phil spoke at the beginning of the Meeting Agenda.

Nomination Committee Update – Board of Social Ministry: There are two names to fill open positions on the Board of Social Ministry, Angel Arnall and Loanna Thompson. Mary Frerking moved to accept these nominations; seconded and approved.

Trustees

Ken reported that he'd received a revised bid from Septagon for installing the two new bathrooms in the TLCLC. Septagon was asked to price up-flush toilets.

Price came in at \$25,850 as opposed to \$28,000 for the regular toilets.

NEW BUSINESS:

Page 6 Social Ministry—Sharing Moment and

Freewill Offering April 15 & 16 for Love INC: Carol Morrison moved to approve these dates; seconded and approved.

Scholarship Guidelines

The Board of Directors reviewed page 34 of the packet. The amendments on the bottom of the page would be replacing the information on the top of the page. Doug Kiehne moved to adopt the amendments. Seconded. Discussion...Ken Greer mentioned the possibility of Scholarships being handled by a Board, possibly Endowment or Executive Committee. It will be considered. Approved.

Constitutional Revision Committee – Andrew Saeger, Buck Katt, Mike Walz

Mary Frerking moved to approve the members of the Committee. Seconded. Discussion...It was asked what is the purpose of this Committee? Chairman Kespohl stated there are 127 proposed constitutional changes they need to review. Andrew Saeger will send the list to the Board of Directors for informational purposes. Approved.

Pastor Gerike's Final Check Update:

Chairman Kespohl stated he has looked in the 1999 handbook. Vacation, sick leave, and holiday are defined and employees carry over one year's worth of days. But, the handbook says that Pastors are exempt. Because there was no policy for the Pastors, Chairman Kespohl called Lee Hagen for advice. Lee said a Pastor who has been at a church as long as ours have usually get five weeks vacation with no carry over. All five weeks are given on the first day of January.

Therefore, Pastor Gerike would have received all five weeks on January 1, 2018. Discussion...We did not file for short term disability, but Ron Barrett is in the process of doing that. If short term disability is approved Pastor Gerike would get 70% of his salary from disability. Note: Pastor Gerike was paid for the three weeks he was in the hospital. For future, Trinity needs in writing what Pastors will receive for vacation, sick leave and holiday. Mary Frerking moved that if the disability payment comes to Pastor Gerike's Estate, then TLC will pay the Estate 100% of 10 days minus 70% of his salary for 15 days. But, if the payment comes to TLC, we will pay 100% of 10 days salary. Seconded.

Discussion. Mary Frerking asked to amend the motion to state that if the disability payment causes a negative to the Estate, the Estate does not pay anything to TLC; amendment seconded and approved. Jacque Eckhoff restated the motion as amended to read: if the disability

payment comes to Pastor Gerike's Estate, then TLC will pay the Estate 100% of 10 days minus 70% of his salary for 15 days. But, if the payment comes to TLC, we will pay 100% of 10 days salary. And, if the disability payment causes a negative to the Estate, the Estate does not pay anything to TLC; seconded and approved.

Good Shepherd Congregational Support

Chairman Kespohl discussed financials for the current school year, as well as enrollment numbers for the 18/19 year. By the end of the current school year, in July, GSLS will be in a \$94,000 deficit. Chairman Kespohl suggested that Trinity Lutheran Church fund the school until the end of the school year. \$30,000 is an approximate amount. The land money cannot be used. If Trinity loans the money to GSLS, when the land money can be used. CLAS will pay Trinity back. CLAS agreed they would do that. Another idea was to ask both congregations, Trinity and Campus, to vote that the land money could be used to finish out the 17/18 school year. Mary Frerking moved to call a Special Assembly of Voters Meeting for Sunday, March 25th following the 10:30 AM service, to discuss GSLS and recommend a release of land money to cover operating expenses to end the 17/18 school year. Seconded. Discussion...Campus can vote on April 5, 2018. Approved.

June Storytelling Conference

Pastor Thieme stated that volunteers are needed, including hosts for our storytellers. Conference is June 28 -30, 2018, however storytellers will come in on the 27th.

Elders Recommendation for Pastoral Support

Doug Kiehne stated they are currently looking at two short term options. First, someone would come in and preach once a month. The Elders recommend the following pay schedule for an ordained Pastor preaching at Trinity:

One Service.....\$75.00 Two Services.....\$100.00 Three Services.....\$150.00

Second, someone would visit shut-ins 20-30 hours a month. The Elders recommend to pay any individuals contracted to assist with this church work \$35/hour plus mileage to be reimbursed at the current IRS rate. Doug Kiehne moved to adopt the pay schedule for an ordained Pastor preaching at Trinity, contingent on no existing policy; seconded and approved. Doug Kiehne moved to have someone visit shut-ins 20-30 hours a month at the rate decided; seconded and approved.

Scholarship Payment

Virginia Propp moved to approve second semester payment to Grace Thieme for the 17/18 school year; seconded and approved.

ANNOUNCEMENTS:

Next Meeting of the Board of Directors will be held on April 10, 2018.

Andrew Saeger will write up the announcement for the Special Assembly of Voters Meeting to be held on March 25, 2018.

Mary Frerking moved to adjourn the meeting at 9:30 p.m.; seconded and approved.

Pastor Thieme led the group in closing prayer.

A blessed Easter to you!

What joy there is in celebrating the resurrection of Jesus which gives us hope for today and assurance of our own resurrection in the future! He promised to prepare a place for us! It is important to remember that there would not be a celebration if not for the suffering that Jesus en-



dured for our sake. He has shown us that suffering can have purpose and can bring about good. Unfortunately, the world does not see it that way. Many people want to do away with suffering by ending lives prematurely instead of trusting God's timing. The following article, "Assisted Suicide Is Not Real Compassion", addresses this issue and offers a better way:

"Proponents of assisted suicide argue that helping someone end their life is a compassionate act. In fact, many of them contend that this lethal, risky practice is consistent with the ethical teachings of the world's great faiths, which call each of us to care for those who are suffering.

"But although those pushing to legalize assisted suicide may have good intentions, the practice for which they advocate could not be more unlike the compassion that our Christian faith asks us to show to our brothers and sisters.

"Compassion, at its root, is about accompanying others through trying times. It does not ignore the reality of death or the fact of human suffering. Instead, it underscores that even in someone's darkest days, people of faith are not allowed to abandon them. We must provide love and accompany them each step of the way.

"As a Lutheran, I can see this clearly modeled in the ministry of Jesus, most notably in how He engaged with those who were suffering. He did not send the sick and afflicted away; instead He said, "Come to me, all you who are weary and burdened, and I will give you rest" (Matthew 11:28 NIV). The relief that Jesus offers includes, but is beyond, physical healing. It is a peace that comes from being loved and comforted. Christians are called to follow His example.

"But assisted suicide is the direct opposite of loving care and companionship. Instead of providing both the medical and personal attention that those near the end of life need and deserve, this practice sends them home with a vial of pills to die alone..... How can we call this a "compassionate" choice? Proponents of assisted suicide contend that it is necessary to relieve the pain of suffering people.

"But this itself is misleading. Evidence from states where assisted suicide is legal, such as Oregon and Washington, shows that the vast majority of those who choose assisted suicide are not motivated by a desire to relieve pain. Instead they cite other reasons for ending their life, such as the worry that they would be a burden on their loved ones if kept alive. This is not "compassion". Instead, legalized assisted suicide perpetuates the tragic myth that the elderly and infirm are "burdens to be dealt with instead of human beings deserving of love and care.

"Furthermore, the latest advances in palliative care and end-of-life treatment have made pain-based arguments for assisted suicide unnecessary. Pain can be managed, and our lawmakers and healthcare system should focus on continuing to advance real care options, not hastening death.....

"Finally, legalizing assisted suicide cannot be considered compassionate given the adverse impact it will likely have on the poor and vulnerable to whom people of faith are called to give special care. Given the economic dynamics of the healthcare industry and the fact that ending life will likely be cheaper than ongoing care, assisted suicide could be pushed on disadvantaged people. It will also likely disincentivize efforts to expand affordable and accessible care for all. In fact, we've already seen evidence of this: a mother of four in California was denied treatment for her cancer, but her insurance company said they could provide her with suicide drugs instead. Is this the type of "compassion" proponents of assisted suicide have in mind? And how can we have real "choice" when medical options are being limited instead of expanded?

"The stark truth is that assisted suicide is not a compassionate practice; it amounts to abandonment of those who need us most, perpetuates dangerous views that the sick and elderly are "burdens," and will unjustly prevent the poor and vulnerable from receiving the care they deserve. Assisted suicide is entirely inconsistent with the values that people of faith hold dear. "It is also inconsistent with who we are as Americans. In a country that prides itself on exceptional healthcare and communities that stick together, let's commit ourselves to advancing real care, not hastening death." (Assisted Suicide Is Not Real Compassion by Virginia Flo, regional director of Minnesota and national conference director of Lutherans For Life, LifeDate, Winter 2016)

Be vigilant and share the Truth when you hear people advocate for physician assisted suicide. It is **not** a compassionate choice and goes against Jesus' example and our charge to "Carry one another's burdens". Won't you help others understand what true compassion really is?




