And he said to him, "Rise and go your way; your faith has made you well" (Luke 17:11-19).

#### OCTOBER 9, 2018 BOARD OF DIRECTORS MINUTES

(Draft Minutes - Yet to be Approved)

The regular monthly meeting of the Board of Directors was called to order on October 9, 2018 at 7:00 p.m. Attendees included Gary Kespohl (Chairman), Jacque Eckhoff (Secretary), Mary Frerking, Andrew Saeger, Virginia Propp, Carol Morrison, Warren Harms, JoAnn Schoenike, Ken Greer, Chris Bailey, Doug McDowell, Doug Kiehne, Annette Kiehne and Pastor Brian Thieme.

Pastor Thieme gave the opening devotion.

Mary Frerking added a Facility Use Request to New Business. Andrew Saeger added a Facility Use Request and Agenda Building for AOV to New Business. Mary Frerking moved to accept the Meeting Agenda with these changes; seconded and approved.

JoAnn Schoenike noted two spelling errors in the September 11, 2018 Minutes. On page 4 it should be spelled "Divine" and page 6 "Boomerang". Virginia Propp moved to accept the Consent Agenda with these changes; seconded and approved.

FINANCIAL SECRETARY - JoAnn Schoenike

For the month of September, the Regular Envelope collections are 121.52% of the anticipated monthly amount. Loose Plate collections are 153.10% and Sunday School are 123.85%. The Total Monthly collections are 122.71% of the monthly anticipated amount of \$40,116. The Total Year to Date collections through the end of September are 100.20% of the anticipated amount of \$383,228.

**BOARD REPORTS:** 

CHRISTIAN ED. - Mary Frerking

Possible activities for Reformation Sunday have been discussed. The BOCE is planning to laminate the placemats left over from the 500th Anniversary celebration last year. They will provide these to all Sunday School families.

Saturday, November 11th, is the date scheduled to begin clean out and reorganization of the Sunday School, Youth and VBS closets. #### EARLY CHILDHOOD ED. - Virginia Propp

Fall/Spring 2018-19 Enrollment is 100% as of 10/3/18. TLCLC will have one FT preschool opening and one TTH toddler opening on 10/16/18, and another TTH opening in January 2019. TLCLC will purchase for review one of each curriculum the LCMS Early Childhood Representatives recommended. Marilyn Simmons will work with TLCLC staff to consider new materials for adoption. Bathroom addition are still on hold, while working with the City of Columbia for plan approval. TLCLC signage artwork was submitted, and delivery will be mid-October. Ministry activities include hosting the LCMS Early Childhood Director's Conference at Trinity on September 29th.

#### STEPHEN MINISTRY PRESENTATION:

JoAnna McDowell and Debbie Antel presented information on Stephen Ministry. It's a ministry system that includes intensive training, resources, structure and ongoing support to congregations to equip and empower a team of lay people to provide confidential one-to-one Christ-centered care to hurting people. It does not replace pastoral care but compliments and expands care of members in crisis. It does not take away authority of the Pastor's role. See Congregation Secretary's notebook for complete information sheet.

#### TREASURER'S REPORT - Warren Harms

For the month ending September 30, 2018, the Church income is \$52,969 and year to date is \$433,239 (71.05% of the total income budgeted for the year). September was a 5-Sunday month. This is <\$22,928> or <5.03%> less than in 2017. The 301-Regular Envelope is down <\$6,417> or <1.73%> less than at the end of September 2017. We should share prayers of thanksgiving as this total for the year through June had been down more than \$15,000 (5.0%) in June.

The total Learning Center income for September is \$57,441 and \$544,574 for the year to date (80.33% of the budgeted income for the year). For the month of September, Church expenditures are \$44,537, and \$385,649 year to date (63.2% of the annual expense budget of \$609,775).

The Learning Center expenditures for September total \$55,843 and \$471,129 year to date which is 69.5% of the annual expense budget of \$677,900 "Extra expenses" in September for the church are in 623-Capital Outlays: Phone jacks installation for \$2,500 and the balance of the surveillance cameras for \$11,780. For the Learning Center on account 741.5-Capital Expenditure, there was \$4,473.40 for the new intercom system consisting of a control card, 12 phones, and installation.

Total reserve accounts at Lutheran Church Extension Fund are now \$197,834.

There is currently no building loan on the books.

Mary Frerking moved to approve the Treasurer's Report; seconded and approved.

**OLD BUSINESS:** 

Servant Trailer: The Board of Directors watched a short video regarding a church in Missouri that has a Servant Trailer and how it works. Pastor Thieme then shared a list of items we have and want for our trailer. Servant Trailer has been added to the 2019 Budget.

Trunk or Treat: Doug McDowell asked members of the Board of Directors to please sign up if they haven't already. He then reported that this year "Sassy Dogs" food cart and Kona Ice will be at Trunk or Treat.

Survey Update: Doug Kiehne reported that the congregational survey is now closed, and 194 people responded. The Elders divided up paper surveys for entry and have received the summary from the District.

Adopt-a-Highway: Highway clean up was done last Saturday, and another will be done in the Spring on Clean up Columbia Day.

Called Worker Benefits: No update; still in process.

Downstairs Bathrooms: Waiting on estimate. The BOD will revisit in November.

Constitution and Bylaw Revisions: 8.1.12.3...the BOD asked to change \$4000 to \$2500, so it reads "up to \$2500". Also, take out the percentage. Virginia Propp moved to approve the change; seconded and approved. It was discussed to let the Board of Youth keep their own account. 7.5.1... JoAnn Schoenike moved to change the wording to "The four (4) elected officers (President, Secretary, Treasurer and Financial Secretary), and the Chairman of the Board of Elders, shall be designated the Executive Committee."; seconded and approved.

Budget 2019: Reviewed

#### **NEW BUSINESS:**

Lay Delegate Nominee: Larry McCoig: JoAnn Schoenike moved to approve Larry McCoig as the Lay Delegate Nominee; seconded and approved.

Expanding Board of Early Childhood Education & Revised Responsibilities: Virginia Propp proposed making the Board of Early Childhood Education a five member board with revised responsibilities. See page 36 of the agenda packet for complete details. If approved, the BOECE has found Christina Hartman and Carole Eilers who are willing to fill the two new positions. Virginia then read reasons for wanting this increase in board members. See list of reasons in Congregational Secretary's notebook. Mary Frerking moved to approve the proposal to increase the number of BOECE voting members from three to five, and to make this recommendation to the AOV; seconded and approved.

TLCLC Dedicated Fund: Virginia Propp stated that the BOECE would like to request to set up a designated account to be funded each year with up to \$10,000 of excess income for TLCLC in order to make large purchases, such as playground equipment and kitchen appliances. These types of purchases are large enough that funds need to be saved up for several years to make the purchase. Warren Harms believes this is already done with the accounting procedures TLC currently uses. Annette Kiehne will work on a proposal.

Frerking Facility Use Request: Mary Frerking is requesting

the gym for use by Abigail's volleyball team. One day a week, 11/1/18 - 4/30/19, for 12-15 people. Warren Harms moved to approve the request; seconded and approved.

Cameron Facility Use Request: Debbie Cameron would like use of the fellowship hall and kitchen for a baby

shower on 11/10/18. Discussion: Conflict exists because set up for Lutherfest will be happening that day. Mary Frerking moved to approve the request, but not for 11/10/19. Debbie will be asked what others day will work; seconded and approved.

Agenda Building for AOV: Andrew Saeger requested that the Executive Committee meet to help with the building of the AOV Agenda Packet. He'd like them to meet before Friday, 10/12/18. Jacque Eckhoff and JoAnn Schoenike are unable to meet, but Chairman Kespohl, Warren Harms and Pastor Thieme will meet to help finalize the packet.

The total Learning Center income for September is \$57,441 Sunday School ran its summer schedule. VBS was successful and \$544,574 for the year to date (80.33% of the budgeted July 10-13th. > Distribution of Excess: The BOD recommends that the AOV adopt a policy that any funds found to be in excess of expenses at the end of the year be distributed as follows: 10% will be donated to missions, the LCMS Missouri District, and the LCMS; and 90% will be placed into Account 190 - Capital Outlays. Angel Arnall moved to approve the recommendation; seconded and approved.

> Release Funds for Youth: The BOD recommends that the AOV ratify the release of \$5600 from Account 527 – Youth Trip to the Board of Youth for use in paying expenses surrounding National Youth Gathering 2019. Angel Arnall moved to approve the recommendation; seconded and approved.

> Budget for 2019: The BOD recommends the AOV adopt the attached Budgets for 2019. Postpone final consideration and adoption until December 2018.

Constitution and Bylaws Revisions: The BOD recommends the AOV adopt the revised Constitution and Bylaws. Consideration and adoption will be postponed until at least December 2018. A booklet of all revisions will be available at the end of the meeting.

Lutheran Church Extension Fund: The LCEF is trying to raise 100 million dollars for loans: 3 years and 4 months at a rate of 4%. There was discussion as to whether TLC should invest. It must be new money. Larry McCoig moved to let the Executive Committee approve a move of up to \$40,000 into this account without BOD recommendation, if it expires October 31, 2018; seconded and approved.

Snow Removal Contract: The Snow Removal Contract for this year is the same as last year. Stephen Harris moved to approve the contract; seconded and approved.

Vision Planning: LCEF met with the Planning Committee recently. If TLC chooses to use LCEF, they along with Pastor Thieme, would lead the discussion for our vision team. \$1500 is the initial cost, but there are four modules total. The meeting is open to the entire congregation. Angel Arnall moved to spend the \$1500 initially to let the group meet ASAP. Then we can revisit in December to decide how to move forward; seconded and approved.







The TLCLC playground surfacing, part of a recycled rubber playground surfacing grant from the Missouri Department of Natural Resources has been installed. The Board of Early Childhood Education would like to sincerely thank **Phil Glenn and Gail Schuster** for their countless hours spent writing the original grant more than six years ago. After the rejection of that grant, Phil Glenn on behalf of Trinity Lutheran Church and with the assistance of the Alliance Defending Freedom followed this issue all the way to the Supreme Court. The decision in favor of Trinity stated that the State of Missouri cannot deny public funds to a church simply because it is a religious organization. Without Phil's hard work and perseverance, this project would not have come to fruition.

The Board of Early Childhood Education would like to thank **Neil Eckhoff** for serving as the project manager for the pour-in-place surfacing installation. He donated his time and that of his crew's along with the use of his personal construction equipment to complete the site preparation,





saving the congregation a substantial amount of money. Thank you also to all the site preparation volunteers who worked with Phil and Neil in September to get the playground prepared for the installation of the new surface.

Thank you to **Virginia Propp** for updating the original grant for re-submission this summer and to both Virginia and Gail Schuster who met with vendors for project estimates. A thank-you also goes to **Andrew Saeger** for assisting with issuance of documentation to the DNR through the on-line portal.

There are several steps left to complete this process and comply with all grant requirements, including the teaching of a recycling curriculum developed for the Learning Center to go with the November 15th America Recycles Day, a national campaign to raise awareness about the benefits of recycling. We thank the **staff of the Learning Center** who will be including this curriculum in their lesson plans. A grand opening celebration will be held during that week, as well. This entire grant process should be completed in December.


