It is Well with my Soul

Horatio Spafford (1828-1888) was a wealthy Chicago lawyer with a thriving legal practice, a beautiful home, a wife, four daughters, and a son. He was a devout Christian and faithful student of the Scriptures.

At the very height of his financial and professional success, Horatio and his wife Anna suffered the tragic loss of their young son. Shortly thereafter on October 8, 1871, the Great Chicago Fire destroyed almost every real estate investment that Spafford had.

In 1873, Spafford scheduled a boat trip to Europe in order to give his wife and daughters a much needed vacation and time to recover from the tragedy. Spafford sent his wife and daughters ahead of him while he remained in Chicago to take care of some unexpected last minute business. Several days later he received notice that his family's ship had encountered a collision. All four of his daughters drowned; only his wife had survived.

With a heavy heart, Spafford boarded a boat that would take him to his grieving Anna in England. It was on this trip that he penned those now famous words, "When sorrow like sea billows roll; it is well, it is well with my soul." (story from Share Faith –"When Peace, like a River – LSB #763).

I tell you this so that I can tell you "it is well with your soul." Our beloved Lord would proclaim to you that your soul is in His hands and no one shall take you from Him.

Christ shed his blood upon the cross for your soul and my soul. He left no trace of sin for us to overcome but bore them all. He paid the price in full.

Satan would have us believe we are unworthy of God's love and have no place in the kingdom of heaven, and he would be right if we stood on our own. However, we do not stand alone, for Christ was nailed to the cross so that you and I may have a place in the kingdom of heaven and be counted worthy of love because of Christ.

The resurrection of our Lord marks and seals His Son's work as acceptable on our behalf. No longer are we captive to sin, death, and the deceptive words of Satan. The great exchange has taken place. Christ gets our sins and we get His inheritance. "It is well with my soul."

If we had ears to hear, we could hear our very names being scribed into the book of life at our baptism. In our baptism is the language of both Good Friday and Easter Sunday.

Do you not know that all of us who have been baptized into Christ Jesus were baptized into his death? We were buried therefore with him by baptism into death, in order that, just as Christ was raised from the dead by the glory of the Father, we too might walk in newness of life. For if we have been united with him in a death like his, we shall certainly be united with him in a resurrection like his. We know that our old self was crucified with him in order that the body of sin might be brought to nothing, so that we would no longer be enslaved to sin. For one who has died has been set free from sin. Now if we have died with Christ, we believe that we will also live with him. (Romans 6:3-6).

No matter the pains, sorrows, afflictions, troubles, or trials in our lives "it is well with our souls." From the rooftops, the hilltops, and mountaintops themselves we can shout "IT IS WELL WITH MY SOUL!"

FINANCIAL SECRETARY - Not Present

For the month of September, the Regular Envelope collections are 113.1% of the anticipated monthly amount. Loose plate collections are 70.08% and Sunday School are 85.36%. The total monthly collections are 110.51% of the monthly anticipated amount of \$41,489.65. The total year to date collections through the end of September are 108.55% of the anticipated amount of \$395,364.03.

CHRISTIAN EDUCATION - Mary Freking

Continuing with "Enduring Faith" curriculum trial. Feedback from teachers has been positive. Will continue trial for next six months. Board plans to sponsor a trunk for Evangelism's Trunk or Treat event. Christmas Eve Service planning will soon begin. Will work with Chris Kespohl and the Choir to contribute to the service. The BOCE is still in need of an additional board member for the current year and will need two new members for the 2020 church year.

EARLY CHILDHOOD EDUCATION - Carole Eilers and Theresa Yeager

Fall enrollment holds steady at 100% and the center was fully staffed with teachers, support staff and afternoon aides (only one position vacant for a substitute staff member). Two teachers will retire in May 2020. Signed a contract with Designer Landscaping for the playground drainage project. 2020 TLCLC budget was submitted to BOD. Director has begun staff evaluations, attended the LCMS Early Childhood Director's Conference, and is working on a travel policy. MU OT students are assisting in the Pre-K classrooms this fall and next spring. Program and Curriculum currently include conscious discipline training, safety week celebrated, parent teacher conferences will be hosted, and reviewing CPH materials to incorporate in Christian curriculum. Facilities progress are roof upgrades, ceiling/ tile water damage, plumbing repair on four faucets and broken sink, and scheduling installation of flooring.

The Church's expenses for September was \$38,094 with year-to-date expenditures for the month ending September 30, 2019 at \$328,162. This includes \$24,204 of current year BOD/AOV approved expenses. Adjusted 2019 actual expenses (\$328,162 less \$24,204) total \$303,958, 69.2% of the annual expenditure budget of \$439,029 (\$540,559 - \$101,530) Pastor Contingency.

The Church's year-to-date nine-month adjusted income over expenses was \$129,886 (i.e., when looking only at the 2019 original budget expenditure accounts). This number is reduced to a nine-month total of \$53,738 if the nine month budgeted portion of the Pastor Contingency (i.e. \$101,530 x 75% = \$76,147) were to be

The Learning Center's income for September was \$62,134 with a year-to-date income for the month ending September 30, 2019 at \$547,737 (77% of the \$711,200 income budgeted for the year).

The Learning Center's total expenditures for September were \$84.181 with year-todate expenditures (for the original 2019 budget) for the month ending September 30, 2019 at \$488,833 (68% of the annual expenditure budget of \$711,200). Additionally, we also recorded expenditures of \$29,472 of current year BOD/AOV approved expenses for flooring and closets in the center.

The Learning Center year-to-date income over expenses was \$29,216. Adjusted yearto-date income over actual expenses (for the original 2019 budgeted accounts) is \$58,688 (i.e. \$29,216 plus \$29,472). Combined (Church and Learning Center) yearto-date income over total expenditures was \$134,898.

Net operating cash available as of September 30, 2019 was \$226,561.

Dedicated accounts totaled \$80,428 as of September 30, 2019.

Lutheran Church Extension Fund (Designated Reserves and \$40K General Operating 4-year 4% CD) accounts totaled \$412,228 as of September 30.

CENTURY LINK INTERNET PLAN - Chairman Kespohl has reviewed the current three year contract. He plans to move forward with a month to month contract after the current contract expires. He is requesting additional bids from Socket and Tranquility. Once the bids are received/reviewed the board can decide if a change in company is required.

ROOF REPAIR - Work has begun on the church and learning center roofs using a company out of St. Louis. Roofing company sent an addendum to the insurance company for excess charges dealing with removal of A/C units and the old swamp cooler that reside on the roof. We are waiting on approval of the addendum from the insurance company. This addendum will extend the price an additional \$79,000 making the new project total \$355,000.

The swamp cooler required an additional replacement purchase of a new A/C unit at a cost of \$4,000. Charlie Cott moved to spend \$4,000 for new A/C unit on TLCLC roof to replace the non-functioning swamp cooler; seconded and approved.

The gym roof was also discussed. It is not currently included in the roof repair project as only portions of one side received hail damage. It was reported that the metal roof has been leaking on and off for more than five years. Guideone has offered a check to cover the repairs to the sections damaged. Chris Bailey moved that the recommendation of BOD is for the AOV to accept the money from Guideone and place it in an interest bearing account that is restricted only for use in replacement of the gym roof; seconded and approved.

NEW BUSINESS

FACILITY USE REQUEST - Larry McCoig moved to allowed Phyllis White to use the Fellowship Hall and Kitchen for a baby shower on November 2, 2019; seconded and approved.

Roof Repair

Trinity received a check for \$249,000 from Guide One, our insurance company.

Chairman Kespohl selected a roofing contractor. \$100,000 has been paid to roofers, authorized by Chairman Kespohl. Paid another \$75,000 this week.

BOD recommends approval of up to \$5,000 above insurance payout to repair southeast corner of roof.

Angel Arnall moved to approve up to \$5,000 above insurance payout to repair the southeast corner of roof; seconded and approved.

BOD recommends approval of up to \$4,000 to replace damaged swamp cooler air conditioning unit on roof. Karen Harms moved to approve up to \$4,000 to replace damaged swamp cooler air conditioning unit on roof; seconded and approved.

A portion of the insurance payout (\$31,000) is intended to cover repairs for hail damage to the west side of the Gym roof. The east side has no damage. Current roofing project does not include work on Gym. BOD recommends approval of placing this portion of the insurance payout in an interest-bearing account and earmarked for future repairs to Gym roof. Angel Arnall moved to approve placing this portion of the insurance payout in an interest-bearing account and earmarked for future repairs to Gym roof; seconded and approved.

Staffing Needs The BOD recommends that the Chairman appoint an exploratory committee of four to figure out the needs and job descriptions for TLC and TLCLC following the retirement of Music/Jesus Time Teacher Phyllis White in May 2020. Angel Arnall moved to ratify the creation of this committee; seconded and approved.

Synodical Constitutional Amendment

Background Information: The Synod convention passed an amendment that needs to be ratified by the congregations. There do not appear to be any substantial or controversial changes in this amendment. Essentially, the amendment uses the term "commissioned minister" in several places rather than listing various types of commissioned ministers. It also allows multi-congregation parishes to (once again) send additional lay advisory representatives to conventions and makes other minor wording changes. The BOD recommends approval of the amendment as proposed. Phil Glenn moved to approve the Synod constitutional amendment as proposed; seconded and approved.

Earlier this year our four leaders attended a week-long training course to equip them to lead the Stephen Ministry at Trinity. Their responsibility and commitment is to implement and develop the program, which includes training people to be caregivers. The exciting adventure in learning started for nine people in mid-October. They began studying, discussing, experiencing, and practicing the skills involved in sharing God's love and compassion with those who especially need these gifts.

Joanna and Larry taught the first four modules and provided in-depth training on these topics:

- † The Person of the Caregiver–five foundational characteristics of the caregiver
- † Feelings: Yours, Mine, and Ours—importance of recognizing and accepting all the feelings that people have
- † The Art of Listening—honed listening skills and found that listening well is extremely helpful and caring but is also hard work
- † Distinctively Christian Caring, Part One—discovered more effective ways of using resources such as prayer and scripture as tools in caring ministry

Caregiver training will continue through the month of February 2020. When the caregivers have completed their training, they will be commissioned and available to be paired with care receivers.



The September Lutherans For Life Regional conference in Rochester,

For Life

Two main topics of discussion were 'how to integrate people with intellectual and developmental disabilities into the Body of Christ' and

'dying naturally with hospice care'.

Rev. Chris Wheatley, a hospice chaplain, alerted the audience to the fact that "all hospices are not the same". He gave an informative talk about questions to ask a hospice before admission. He asserted that it is imperative that one interview a hospice agency before entrusting oneself or a loved one to its care. The services one hospice provides may be very different than those provided by another hospice. In addition, the philosophy of the agency is vitally important. A hospice that respects the sanctity of life, that truly abides by the founding principles of hospice which are to maintain dignity, to increase quality of life, and to provide comfort and pain control is a safe haven for patients in need of expert end-of-life care. He said that unfortunately, the aim of many hospices has shifted from helping patients who are dying to helping patients die more quickly!

Below is a list of questions Reverend Wheatley recommends to ask if you are looking for a life-centered hospice. For an even more extensive list, see www.HALOrganization.com, the website for Healthcare Advocacy and Leadership Organization.

WHAT SHOULD I ASK?

- 1. How do you determine what is palliative, and what is curative?
- 2. Do you accept clients on oxygen? Do you pay for it?
- 3. Do you accept clients on fluids? Do you pay for it?
- 4. Do you accept clients on feeding tubes? Do you pay for it? What is your procedure for infection around a feeding tube site?
- 5. How do you determine the correct dosages of pain medication? What non-pharmacological interventions do you employ to treat pain?
- 6. How do you employ morphine? What has been your experience with it?
- 7. Do you employ palliative sedation? If so, when?
- 8. Do you employ palliative chemo? If so, when?
- 9. Who decides when to discontinue a treatment? What input is given by hospice staff, my family, my agent?
- 10. Can I keep my primary doctor? How does your medical director work and communicate with my primary?
- 11. Does your hospice have a policy regarding physician assisted suicide? What is it?/Why not?

Rev. Wheatley believes that the American hospice movement is currently at a crossroads, and it will soon decide whether it continues to support life until natural death or enters the field of medical killing. Ask questions and get the answers in writing before committing to a particular agency.

Sugar and Spice and Everything Necessary

Variety is the spice of the mission field. But it's more than a dash of cayenne or a chiffonade of basil; the Gospel goes forth through missionaries' diverse gifts.

I recently loaned my loaf pan to a friend who was making [gluten-free] banana bread; she'd added an extra banana and chocolate chips. Bewildered at her laxness about something so precise, I reflected on my own recent banana bread experience...and 1 Corinthians 12:4:

"Now there are varieties of gifts, but the same Spirit; and there are varieties of service, but the same Lord; and there are varieties of activities, but it is the same God who empowers them all in everyone."

I'll never know how big a "medium" banana is, so my interest was piqued by an America's Test Kitchen recipe that involved microwaving the bananas and reducing their juices. My friend was equally bewildered at my technical precision.

Varieties of gifts. "Missions" often calls to mind pastors. There is no mission sans Word and sacrament, but there are also deaconesses. Teachers. Nurses. Photographers. The LAC regional team even hosted a dental hygienist. Everything else about missionaries is just as varied: education, musical ability, life stage, family dynamic. We're all identical, though, in that we share the same God. It's not about us. It's about Him, and His mission, and the Spirit with which

He endowed each of us so that we might become participants in that mission. And it is the Spirit and the Spirit only that creates and nurtures faith—the faith I get to share day in and day out.

FYI, both recipes were worth repeating; I might even add chocolate chips next time!
