Another year of commercialization ~ Christmas decorations up before Halloween, malls packed with "holiday" shoppers," feel-good movies teaching the real meaning of Christmas without teaching the real meaning of Christmas. Besides rolling our eyes and huffing and puffing about how Christ is pristmas what are we to do?

left out of Christmas, what are we to do?

Well, let's take a look at Acts 17 at how St. Paul faced the challenges of an unbelieving world.

¹⁶Now while Paul was waiting for them at Athens, his spirit was provoked within him as he saw that the city was full of idols... ²²So Paul, standing in the midst of the Areopagus, said: "Men of Athens, I perceive that in every way you are very religious. ²³For as I passed along and observed the objects of your worship, I found also an altar with this inscription, 'To the unknown god.' What therefore you worship as unknown, this I proclaim to you. ²⁴The God who made the world and everything in it, being Lord of heaven and earth, does not live in temples made by man, ²⁵nor is he served by human hands, as though he needed anything, since he himself gives to all mankind life and breath and everything.

The people of Athens worshiped a plethora of "feel good gods," but they missed out on who the real God is and what He really did. Paul took the opportunity, picked out what they thought they knew, and witnessed to them about the crucified and resurrected Christ. True, there were those who mocked the truth, but there were also those who believed.

³²Now when they heard of the resurrection of the dead, some mocked. But others said, "We will hear you again about this." ³³So Paul went out from their midst. ³⁴But some men joined him and believed, among whom also were Dionysius the Areopagite and a woman named Damaris and others with them.

We have an opportunity. The commercialization of Christmas may abound; but in the midst of it, the truth may be found. We can take the opportunity to draw out the truth in those words or moments. Draw out the truth of the lifesaving Christ who came into the flesh in this sin fallen world. We get to shine a light in the midst of darkness!

Let's look at the first few lines of "Hark! The Herald Angels Sing."

Hark! The herald angels sing, // "Glory to the newborn King; Peace on earth and mercy mild, // God and sinners reconciled!"

Or the last verse of "God Tell It on the Mountain."

Down in a lonely manger // The humble Christ was born;

Even the true story of Saint Nicolas (aka Santa), who was a servant of God that reflected His love, can serve as a witness.

Does such a witness guarantee success? No, but it may mean the Lord will use our words to draw some to Him. St. Paul himself in Acts 17 shows us this truth. "³⁴But some men joined him and believed."

Here we go again, another year to share the peace, joy, forgiveness, and love of Christ we ourselves have received. Opportunities abound.

And the angel said to them, "Fear not, for behold, I bring you good news of a great joy that will be for all the people. For unto you is born this day in the city of David a Savior, who is Christ the Lord. (Luke 2:10-11).

NOVEMBER 12, 2019 BOARD OF DIRECTORS MINUTES (Draft Minutes - Yet to be Approved)

The regular monthly meeting of the Board of Directors was called to order on November 12, 2019 at 7:02 p.m.

Attendees included Gary Kespohl (Chairman), Jacque Eckhoff (Secretary), James Harms, Mary Frerking, Carol Eilers, Ron Barrett, Angel Arnall & Chris Cott.

Chairman Kespohl opened in prayer and Ron Barrett gave the opening devotion.

Chairman Kespohl added Exploratory Committee Announcement and Socket Proposal to Old Business, and Renovation of Pastor Gerike's office to New Business. Carol Eilers added Playground Safety Improvement to New Business. Angel Arnall moved to approve the Meeting Agenda with these additions; seconded and approved.

Angel Arnall moved to approve the Consent Agenda; seconded and approved. The Consent Agenda meeting minutes and reports are filed in the Congregation Secretary's notebook.

The following are summaries of the reports, with the name of the board representative at the Board of Directors meeting listed:

PASTOR'S REPORT - Ron Barrett

Rev. Spotts is visiting 2/3 of the Homebound each month.

Rev. Rod Benkendorf (Lutheran Heritage Foundation) preached Nov. 10/11th.

Pastor Thieme will be on vacation November 20th - 23rd.

There will be a guest preacher for Thanksgiving Day.

Pastoral visits continue to be made with individuals, couples, families, and members of the community at large.

Sunday morning study is on the book of Daniel, and the Monday morning class is going through the Large Catechism (Lord's Prayer).

The Memorial for Pastor Thieme's mother will be held on November 30th in Fort Wavne, Indiana.

FINANCIAL SECRETARY - Not Present

For the month of October, the Regular Envelope collections are 104.94% of the anticipated monthly amount. Loose Plate collections are 81.34% and Sunday School are 120.86%. The Total Monthly collections are 103.87% of the monthly anticipated amount of \$36,544.53. The Total Year to Date collections through the end of October are 108.12% of the anticipated amount of \$400,777.42.

BOARD REPORTS:

CHRISTIAN EDUCATION - Mary Frerking

The BOCE is continuing with their new curriculum, "Enduring Faith". The feedback from teachers has been positive, so they will renew the curriculum for an additional six months. Planning for the participation of all church youth in the Christmas Eve Service has begun. Practice will begin during Sunday School hour on December 1st, and dress rehearsal will be December 19th with all the children in the Sanctuary. The BOCE is still in need of additional board members.

EARLY CHILDHOOD EDUCATION - Carol Eilers Fall enrollment is at 100%. Four afternoon staff that live in Illinois need extra screening with a complicated process in Illinois. It will require extra planning to hire Illinois residents. Conscious Discipline Training is on-going. Roof work has been completed, playground work began on 11/4/19, flooring work began on 11/8/19, and TLCLC is working with the Trustees to install half doors on three Preschool classrooms for safety reasons.

ELDERS - Ron Barrett

The Elders will host a light lunch and dinner on December 4th, the first Wednesday of Advent. Schedule of Services and Communions were approved for 2020. A combined service was approved for All Saints Day on Sunday, November 1, 2020. Larry McCoig sent a packet to Rev. Schultz. It was received and will be reviewed by Rev. Schultz. Larry McCoig then sent a formal letter to Rev. Schultz's congregation.

VISIONING COMMITTEE REPORT: Larry Samuel Larry Samuel moved to recommend amending the Schedule of Services for 2020 so that the four 5th Sundays are combined services. Motion died for lack of a second.

TREASURER'S REPORT - James Harms (Treasurer) The Church's income for October was \$41,421 with a year-to-date income for the month ending October 31, 2019 at \$475,265 (88 % of the \$540,599 income budgeted for the year).

The Church's cash expenditures for October was \$34,680 with year-to-date expenditures for the month ending October 31, 2019 at \$362,842. This includes \$29,666 of Current Year BOD/AOV approved expenses. Adjusted 2019 expenditures (\$362,842 less \$29,666) total \$333,176, 76 % of the annual expenditure budget of \$439,029 (\$540,559 - \$101,530) Pastor Contingency).

The Church's year-to-date ten-month adjusted income over expenditures was \$142,089 (i.e, when looking only at the 2019 original budget expenditure accounts). This number would be reduced to a ten- month total of \$57,819 if the ten month budgeted portion of the Pastor Contingency (i.e., \$101,530 x 83% = \$84,270) were to be deducted.

The Learning Center's income for October was \$61,696 with a year-to-date income for the month ending October 31, 2019 at \$609,433 (86 % of the \$711,200 income budgeted for the year).

The Learning Center's total expenditures for October were \$59,107 with year-todate expenditures (for the original 2019 budget) for the month ending October 31, 2019 at \$546,391 (77 % of the annual expenditure budget of \$711,200). Additionally, we also recorded expenditures of \$30,020 of Current Year BOD/AOV approved expenditures for Flooring, for Closets, and the Playground in the Learning Center.

The Learning Center total year-to-date income over expenditures was \$31,806, however the adjusted year-to-date income over actual expenditures (for the original 2019 budgeted accounts) is \$61,826 (i.e., \$31,806 plus \$30,020). Combined (Church and Learning Center) year-to-date income over total expenditures was \$144.229.

Net operating cash available as of October 31, 2019 was \$238,054.

Dedicated accounts totaled a net amount of cash of \$81,255 as of October 31,2019. The Lutheran Witness Dedicated account was negative by \$195.51.

Lutheran Church Extension Fund (Designated Reserves & \$41K General Operating 4-yr 4% CD) accounts totaled \$412,436 as of October 31, 2019.

The three Endowment Fund accounts held at the LCMS Foundation by Trinity totaled \$100,346.

During the month of October, the church received a check from our GuideOne insurance policy of \$249,769 for repairing our hail damaged roof. During this month we paid this amount to FM Roofing for a new roof, gutters, and other roof work. On September 30th this project was still in progress with additional insurance payments to be received and additional work to be completed by the contractor. The gym roof was not repaired. At the last AOV meeting the voters approved that the insurance proceeds for this repair (of the gym roof) would be deposited in an interest bearing account, and it would be designated to be expended only on the replacement of this roof at some time in the future. Angel Arnall moved to approve the Treasurer's Report; seconded and approved.

OLD BUSINESS:

Removed Pews / Church Chairs The chairs are approximately \$100 each, and there is a need for four chairs. The Elders recommend up to \$400 for the purchase of the four chairs. Ron Barrett moved to spend up to \$400 for four chairs to be placed in the sanctuary where pews were removed; seconded and approved.

Roofing Update The roof is done except for some HVAC work. They also cracked the sidewalk in the back of the church. They will fix the sidewalk.

Flooring Update Friday afternoon the two classrooms above the gym were laid. They will be coming back this this week to do the hallway only.

Exploratory Committee for DCE Possibility w/TLCLC At this point, Chairman Kespohl has two yes and two maybe.

Socket Proposal 100mb/5mb \$150 100mb/10mb \$225 200mb/10mb \$290 Chairman Kespohl will research more before the December BOD meeting.

TLCLC Playground Safety Carol Eilers reported we need to upgrade pea gravel and sand areas. One estimate is \$6000. Safety regulations say the playground should have 9" of compressed material, but ours currently has 1".





Dear Friends in the name of Jesus, the baby and our Savior.

"As we thoughtfully ponder and anticipate the celebration of the birth of our Lord and Savior Jesus Christ, it is appropriate that we remember that moment of time in Lutherans the life of each one of us when life began...a moment when we were changed from nothing into something; from nothing into everything. At that fraction of time called conception, we were in the presence of the One who is life, who is light and who is love. At that time of conception there was direction, destiny and power

because IN THE BEGINNING GOD created... He made everything, including the incredible human brain. The human brain ranks among the greatest wonders of God's creation. At that moment of conception, there is in the single fertilized egg (that which each one of us once was) 27 times more information than is found in an entire set of the Encyclopedia Britannica! The truth is that you and I didn't **come** from a fetus, an embryo or a fertilized egg. You and I once **were** a fetus, an embryo, a fertilized egg. Each individual life is a continuum that begins at conception. The same is true for Jesus. The Body that lay in the manger, the Body that hung on the cross, the Body that rose from the crypt was a body given to Jesus at His conception in the womb of Mary.

Before we were formed (Psalm 139), before God's hands made us and fashioned us into an intricate unity (Job 10:8, 12), God knew us, loved us and had a plan for us. In a world in which so many people have a poor self-image, lack self-esteem and feel rejected and unwanted, the conception, life, death and resurrection of Jesus say to each one of us, "you are so special, so unique, so valuable that you are worth dying for."

When a young child was asked how he got out of his mother's tummy, he exclaimed, "God made a baby door!" With all the biological, medical and scientific language we use to describe pregnancy and childbirth, fundamentally, that is what it really is. God made a baby door for physical life *and* for spiritual life, because it was God's own Baby, His own Son, who through His conception, life, death and resurrection became the Door by which each of us was birthed into His family. That's cause for celebration! We ought to be so filled with the joy of being alive, so grateful for the gift of created life, that others seeing us will say, "teach me what you know; teach me your joy; teach me your peace; teach me your LORD!" Let the celebration begin!" (The preceding article was adapted with permission from Dr. Jean Garton's speech at the Southern District Convention of LCMS in July 1997)

To learn more about Jesus' journey through the womb, you might enjoy the following book:

Three Inches, Two Ounces - Reflections on Jesus in the womb based on Luke 1:56 - Jesus, who was formed in the womb of Mary, who began life smaller than a grain of salt, grew to three inches long and weighed two ounces, became a newborn in the Bethlehem manger, and lived a sinless life to become a 33-year-old who hung on a cross outside of Jerusalem. He did this so that you might be saved from the power of the devil, so that you might receive forgiveness of sins, and so that you might spend eternal life with Him in Paradise. The author, Rev. Michael J. Schmidt, is pastor at Peace Lutheran Church, Natoma, Kansas, and First Lutheran Church, Plainville, Kansas.

Pastor Salemink, executive director of Lutherans For Life, ties Jesus' birth to our adoption into His family and the blessings of human adoptions based on Galatians 4:4-5: "But when the set time had fully come, God sent His Son to be born of a woman, so that He would be born under the law in order to redeem those under the law, so that we would be adopted as sons."

"Adoption makes up the Christian's identity. We belong because God has adopted us. He has not begotten us from His own substance like the Eternal Son. And we do not always behave as His children and reflect His character. Still, He has chosen us who did not first choose Him. He calls us His beloved and declares Himself well-pleased with us. Our Almighty Maker comes to us childlike in Jesus Christ. He abandons His Only Begotten Son to secure us a space in His kingdom and household and family. No matter what age, appearance, ability, or history, human beings may have Lord God for our Heavenly Father. His adoptive washing of Holy Baptism births us anew and from above and forever. Sin renders us unworthy, but the Lamb once slain and raised again ensures we never end up unwanted.

"Adoption on earth embodies this grace. Christians engage in adopting not only because we desire to raise children but also– and above all-because the Most High desires their survival and salvation. We adopt because we have been so adopted. We adopt because little ones need homes. We adopt because we have homes and families to share. Life issues mean more than just political debates. Life issues involve more than just personal choices or someone else's problems. Life issues are always people and Gospel." (Pastor Michael Salemink, executive director of Lutherans For Life, LifeDate, Fall, 2019)

Have a blessed Christmas in Christ, who gives value to all human life from the moment of conception to the moment of natural death.
