Dearly beloved of the Lord at Trinity: Let us pray.

Almighty God, merciful Father, Your thoughts are not our thoughts, Your ways are not our ways. In Your wisdom, You have permitted this pandemic to befall us. We implore You, let not the hearts of

Your people despair nor our faith fail us but sustain and comfort us. Direct all efforts to attend the stricken, console the bereaved, and protect the helpless. Bring hope and healing that we may find relief and restoration; through Jesus Christ, our Lord. Amen.

Much of the following information has already been shared with many of you through email, but please read on because there have been some updates since mid-March.

Email is the best way that we have to communicate important information with the congregation quickly. If you have an email address but have not been receiving emails from Trinity, please email church@trinity-lcms.org with your email address so that we can add you to the list.

On Monday, March 16, 2020 the Columbia City Council enacted an emergency declaration in reaction to the COVID-19 pandemic. On Wednesday, March 25, 2020 Boone County and the City of Columbia amended the emergency declaration into a stay-at-home order for all non-essential activities.

After difficult deliberation and consultation with the Board of Elders and other congregational leaders, the following decisions have been made.

- All onsite meetings and activities at Trinity are canceled for the present.
- Wednesday Lenten services and Sunday services will take place with members remaining in their homes connecting through the means described below. Only Pastor(s), an organist, and a designated small choir to sing the hymns will be present.

#### **Holy Communion:**

Out of love for your neighbor, I am asking you to forego what is rightfully yours – the physical presence of Christ in the Supper for which you rightly hunger. I am also asking you to heed the request of the civil authority set over us by God for our good.

You have undoubtedly heard the call to not assemble in order to "flatten the curve" so our health care system will not be overrun. While I ask you to love your neighbor, please contact me at (573) 268-3241 to schedule a time to come to Trinity to receive the Supper. At the appointed time drive up to the front of the church and park. I will deliver the Lord's Body and Blood to you while you remain in your vehicle.




#### Offerings and Contributions:

Loose Plate collections are 130.89% and Sunday School are 117.28%. Total Monthly collections are 105.95% of the monthly anticipated amount of \$36,114.97. Total Year to Date collections through the end of January are 111.82% of the anticipated amount of \$74,246.31.

Planning materials and some decorating supplies have been ordered for the summer's VBS. The date for VBS has not yet been set.

EARLY CHILDHOOD EDUCATION - Carol Eilers

- Maintaining 100% enrollment as of February 29, 2020.
- Fully staffed for teachers, support staff and substitutes. Hired two afternoon aides and one aide resigned. Seeking advice regarding advertising platform for open positions.
- Melissa Remer-Phifer's application for the state TEACH program was accepted.
- BOECE had a successful Meet-Greet-Eat event for TLCLC staff on 2/19/20. Agenda included an activity and discussion of vision and values.
- Staff surveys to gain insight from staff on strengths and areas of improvement are in the process of being returned.
- Vision development process is nearing completion. Will be shared with Pastor BOD, TLC congregation and LCMC Alan Freeman.
- Task force committee established within BOECE to evaluate the longer term financial strategy on tuition/salary/sibling discounts/etc. as affected by the MO state minimum wage schedule. The BOECE did reaffirm our goal to have quality staff and to pay appropriately, maintaining financial integrity, and to always strive to the highest threshold in all we do for this ministry.
- Discussed Evangelism Board wanting to work with TLCLC no specifics yet.
- Annette walked the BOECE through what the triggers and process will be if Missouri issues a Coronavirus health alert. TLCLC follows a rigid sanitation protocol regarding

tables/toys/etc and follows CDC standards on personal accounts total \$588,988. January 31, 2020 TLC LCMS sanitation/health measures.

- Facility improvements continue: painting projects, office upgrades, flooring, bathrooms.

TREASURER'S REPORT - James Harms (Treasurer)

(2 months or 16.6667% of the year) February's Church income was \$38,502 with a year-to-date income for the month ending February 29, 2020 of \$86,721 (16% of the years \$541,875 budgeted income).

February's Church expenditures were \$34,279 with a year-todate expense total for the month ending February 29, 2020 of \$66,225 (15.117% of the years \$438,079 budgeted expenditures (\$541,875 budget - \$103,796) Pastor Contingency).

The Church's year-to-date two-month income over expenditures was \$20,486. This number is reduced to \$3,187 when the budgeted portion of the \$103,796 Pastor Contingency is deducted.

February's Learning Center income was \$66,573 with a yearto-date income for the month ending February 29, 2020 of \$135,447 (18.5% of the years \$732,000 budgeted income).

February's Learning Center expenditures were \$48,046 with a year-to-date expense total for the month ending February 29, 2020 of \$93,303 (12.75% of the annual expenditure budget of \$732,000).

The Learning Center's year-to-date two-month income over ANNOUNCEMENTS: expenditures was \$42,145. Combined (Church and Learning Center) income over budgeted expenditures • The next Board of Directors meeting will be held on April totaled \$62,631. This amount is reduced to \$54,038 after 14, 2020. \$8,593 in BOD & AOV Expenditures.

Prior & Current Year BOD/AOV approved expenditures paid in February totaled \$5,782. Acct 995.1 TLC BOD/ AOV App: \$1,727.07 expenses

Foundation Endowment Fund account value was \$104,850.

#### Blessings to you in the name of the Triune God,

As this is written, it seems that everything is out of control. Cancellations, quarantines, shortages of hand sanitizers and toilet paper! With fear running rampant, it's important to remember that God is our Creator, Redeemer and Sustainer. He knows and sustains every human life because He is the One Who gives value to each and every one. Please be encouraged by the following article from the book "Grounded in God's Word, Commentaries on

Life", published by Lutherans For Life in conjunction with Concordia Publishing House:

#### HAVE HOPE! GOD IS IN CONTROL: "WHEN EVERYTHING FALLS APART"

"When people's lives are out of control, the question a Christian needs answered is "Is God in control?" For if things are both out of our hands and out of God's hands, then all is lost. It is one thing to believe God is in control when we are also in control of things but another to come to that conviction when everything is falling apart around us. As Paul suffered much in his ministry, it is reasonable to believe that he did not come to believe this question easily. We can imagine Paul, a man trained in the way of the Pharisees, not easily letting go of the idea that *evil doers suffer*, *but not the one who follows God*. But Paul had the prophets before him as witness to the suffering of the righteous and, in fact, the witness of Jesus' own suffering and death. Paul's first comfort in suffering is to keep things in perspective. He reasoned, we suffer in this life, but it does not compare in intensity with the glory of heaven where suffering is no more.

"Heaven's coming will benefit not only the faithful but all things. All creation awaits the coming of the kingdom of God. The bond between mankind and this world is strong. We were originally made to live for this world with God. Eden is the world God make for mankind, and it was only because of sin that God brought about something better.

"God's redemption has affected not only people but also all things created. Since the physical world has suffered the results of man's sin, even inanimate things need redemption and in fact will receive it in Christ. All creation needed to be bought back from sin by God, and Paul spells out why. When Adam sinned, this world became corrupt, but it remained the world God gave us in which to live. In the midst of corruption, God also gave hope. That hope is not just for escape from this world but for courage and faithfulness to live in it. We may not be able to change the world much, but we can live faithful to our calling in it. In many things in life, we are not called to be successful in our efforts but to be faithful in bearing responsibility for them.

"In addition to man's spiritual and creation's physical need for redemption, our bodies also need redeeming. From our Redeemer we learn that God values both our physical and spiritual needs for redemption. Our sins and their forgiveness are connected to our relationship with God but so are the effects of sin on the body. Abuse, neglect, and immoral indulgence are the choices we make that cause our bodies to fail us and become weak, sick, and die. Since there is no way anyone can avoid that outcome, our bodies also need redemption by the only One who can redeem them, Jesus Christ, God in the flesh. Paul finds hope in God's saving response to the groaning of this world in sin. It is a hope that lifts us up for heaven but also fortifies us for this life.

"As Christians we are not in control of this life, neither the world's nor ours. Yet we know that compared to the saving power of God, the absence of control in this life doesn't matter. We don't need to be in control because God is in control. We know God is in control by the evidence of Jesus Christ's death and resurrection. The cross of Christ and the crosses we bear in His name are not the last word. *The last word is the new life in Christ, the resurrection of the body, and life everlasting.*" (Dr. Richard C. Eyer, "Have Hope! God Is in Control"; Grounded in God's Word, Commentaries on Life, Lutherans For Life, Concordia Publishing House, 2018)
