Trinity Lutheran Church – Columbia, MO



It is a true Christian joy to have been called to serve Trinity as your pastor as you approach celebrating 100 years of God's grace in Christ in Word and Sacrament. I pray that as I begin serving, God continues to bless the eternal work He is doing through His Spirit in all of you in Columbia and beyond!

I hail from eastern Colorado, from the little town of Strasburg, not too far from the Denver metro area, but nonetheless part of the windswept plains. Or as I like to refer to it as: "not postcard Colorado" or "the part that Kansas forgot." Strasburg's claim to fame is the location where the last railroad spike was driven on the Kansas-Pacific Railroad that made the first true transcontinental railroad crossing (without a transfer) possible.

My father, Matthew, decided to build a "little house on the prairie," much to my mother's chagrin. Dad has been in agribusiness his entire life and travels extensively throughout the rural, mountainous western US. My mom, Barbara, has worked in public health and education, but now enjoys gently scolding her numerous piano students for not practicing (yet, still doling out tons of candy). John, my younger brother, is employed in energy infrastructure and is also following my father's footsteps in building his own home, perhaps wisely, as a bachelor. Both younger sisters, Elizabeth and Anna, are nurses. Anna, the youngest, lives in Denver and works as a labor and delivery nurse. Elizabeth is an ophthalmology operating room nurse and lives near my parents with her husband Richard and their new arrival, Juliette.

My confirmation catechist, James Robinson, and Pastor Frederick Skov first put the "seminary bug" in my ear in 2002, but I downplayed it and went off to college resolved on pursuing a career with the Foreign Service. An internship with the US Congress and some campaign work quickly deterred me from that intention. When Jesus says Christians can't serve God and man, I bullheadedly took that as a challenge rather than the truth. During university, my entire life became centered around University Lutheran Chapel serving as sexton, sacristan, and treasurer. At my grandparents' church, a very young Rev. Bryan Wolfmueller, two vicars, Rev. Clint Stark and Michael Meyer, and the chapel's pastor, Daniel Burhop, reignited my interest in the pastoral ministry. After graduating in 2008 from the University of Colorado at Boulder in International Affairs and Economics, I studied Greek and Hebrew for two years at Martin Luther College in New Ulm, Minnesota. Attending seminary was now the surely in the future, but exactly when was still to be determined. I also worked as an assistant winemaker, learning the oenology of cold hardy varietals. In 2012, after six years in school it was time for a break, and I opted to be commissioned as a teacher and was sent off to Beijing, China. My real work in China, however, was moonlighting as a friendship evangelist. This work should not be publicized in order to keep the authorities from upsetting Jesus' apple cart. (I look forward to most certainly sharing stories from my time there, but not in print.) For now, let's just say I focused strongly on student needs, spending afternoons and evenings after class playing badminton and mentoring. I assisted in producing the humanities curriculum for the first home-grown college preparatory program for a public school in China. As part of my work, I organized and led several experiential learning trips for student groups in the wilderness of the American west. In 2015, after four years abroad and hundreds of bizarre gastronomic experiences, I realized that to teach and counsel more effectively, I needed formal theological training and began at Concordia Theological Seminary Fort Wayne. I finished the Master of Divinity (MDiv) degree in 2019, and opted to stay for one more year (a glutton for punishment, I suppose) to begin working on the Master of Sacred Theology degree (STM). The MDiv is the "how to pastor" degree while the STM is an academic degree that focuses in a specific area of theology. My area of study is theological anthropology and narrows down to the eschatological role of modern Christology for the believer (do the words make you as sleepy as they do me?).

When I'm not agonizing over the STM, I enjoy skiing, politics, reading, boating/waterskiing, the American west, writing, and traveling for the sake of food and studying history. As I write, I'm near the end of the Santa Fe Trail at Fort Union, New Mexico. I can hardly wait to begin serving you at the beginning of the trail (so close to Columbia!) with God's gifts, that we may all be nurtured and grow in the grace and knowledge of our Lord Jesus Christ. May the peace which Christ brings always be our confidence!

As with all services and events, if you are over 65 or have an underlying medical condition, the City of Columbia requires us to encourage you to stay home.

RETURN TO IN-PERSON WORSHIP SERVICES AND EVENTS

Now that the state and local pandemic restrictions are being loosened, Trinity has resumed in-person worship services and on-site events. Based on the most recent orders from the City of Columbia, we are observing the following practices:

- ✤ Services are held at regular times: 8:00 a.m. and 10:30 a.m. on Sunday and 6:00 p.m. on Monday.
- The 8:00 a.m. service will be livestreamed at <u>www.facebook.com/trinitylutherancomo</u>.
- ✤ Communion will be offered at worship services as scheduled. Communion will also be available at other advertised times and by appointment.
- There will be no in-person Sunday School or Fellowship Hour at this time. Children's Sunday School will be meeting via Zoom at 9:30 a.m. An adult Bible Study will be available at <u>www.facebook.com/trinitylutherancomo</u>.



- ✤ If you are in the high-risk group as defined by the City of Columbia (65 or older or have an underlying medical condition), you are encouraged not to attend services or events.
- If you have a cough, fever, shortness of breath, loss of taste or smell, or other COVID-19 symptoms, please do not attend.



- ✤ We are following strict social distancing guidelines. Households are encouraged to sit together, but groups must sit at least six feet from the nearest group with vacant pews both in front of and behind each occupied pew. Please follow all written and verbal instructions given at the service.
- The most recent guidelines do not limit our occupancy to a specific number, but our socially-distant capacity is just over 100 people.
- ✤ Worshipers may, at their discretion, wear face masks. Face masks are not required while attending worship services.
- If you need to visit the Church Office, please consider wearing a face mask. Some of our staff are in the high-risk group.



- Meetings and events may again be held on site. Social distancing guidelines and all City of Columbia orders must be followed including guidelines for food preparation and service. As with worship services, high-risk and symptomatic individuals are encouraged not to attend events and meetings. Please contact the Church Office if your organization, group, board, etc. plans to resume meeting at Trinity.



Blessings to you in the name of God our Creator, Jesus our Redeemer, and the Holy Spirit who sustains us.

Last month's article began with "God is good and in control." It's still important to remember when everything else seems out of control, God calls us to trust in Him in all circumstances. He also calls us to be informed citizens and participate in the government He has set before us. This month's newsletter article will begin with the first half of an article from Lutherans For Life entitled "Is Abortion an Election Issue?"

So, Chris tells Jamie, "I just couldn't cast a vote for someone who supports abortion." And Jamie says, "You know, Chris, abortion's not the only voting issue. Other things matter to elections and politics too. Seems kind of narrow-minded for you to fixate on just that one."

Have you ever heard a conversation like this? Have you ever had a conversation like this? Have you ever met someone like Chris or Jamie? Have you ever felt like Chris? Like Jamie? Is abortion an election issue? No and Yes. No, abortion is never just an election issue. But yes, abortion is always at least an election issue. Here are ten reasons why:

1. Abortion isn't just a political issue. Abortion has to do with facts and truth about the science of human life—embryos and fetuses are living human beings as much as you and me. Abortion deals with the physical and psychological welfare of the most vulnerable among us-it kills children and makes mothers suffer. Abortion executes the injustice of discriminating against one another-unborn babies face deprivation and dving based only on their age, appearance, experiences, environment, or abilities. And abortion involves moral assessments and enforcements—who has the right to life, who has the authority to take life, when may we limit one's lifestyle because it infringes upon somebody else's survival?

2. Abortion isn't just a single issue. Abortion is a conclusion that comes from a whole set of principles. It relates to economics, medicine and health care, justice and civil rights. It shows how one understands the roles of government and law-shouldn't we protect the weakest? It affects one's sense of the community's commitments to our underprivileged and endangered—wouldn't we want to make up for what they lack rather than take even the little they have? It informs how one feels about our relationships to each other as citizens in a society-can't we care instead of discarding? And abortion has long-term consequences and global implications for both individual bodies and entire populations.

3. Abortion isn't simply a popular-opinion issue. Surveys cannot establish rights and wrongs. Polls cannot determine parental duties. Ballots cannot define a human life's worth and purpose. And even majorities cannot undo death. Of course, people have different perspectives and emotional disputes about abortion access. But none of these alters the logical, biological, social, and ethical realities of the matter. Abortion shapes the very nature of our nation and the makeup of our culture, not to mention the very lives of its victims.

FINANCIAL SECRETARY - JoAnn Schoenike

For the month of May, the Regular Envelope collections are 113.62% of the anticipated monthly amount. Loose Plate collections are 125.83% and Sunday School are 0%. The Total Monthly collections are 113.62% of the monthly anticipated amount of \$38,823.91. The Total Year to Date collections through the end of May are 105.78% of the anticipated amount of \$199,532.72.

BOARD REPORTS:

CHRISTIAN EDUCATION - Mary Frerking

The BOCE has hosted three Remote Zoom Sunday school lessons to date (5/24-6/7). The lessons are held 9:30-10:00 am. In the Remote lessons, the same format as regular "in person" lessons is followed: welcome, opening prayer, songs, lesson, closing prayers, announcements and birthdays. The BOCE also sends paper copies of each week's lesson materials to the children at their home, along reduced to \$34,090 when the budgeted portion of the \$93,489 with stickers and coloring pages. For the three Remote lessons, the Enduring Faith curriculum was completed. New curriculum begins on June 14th. Also beginning next week, John Frerking will begin a new Zoom Sunday School class for incoming 6-8th grade children. After discussing options, the BOCE has decided not to hold VBS this summer. However, a VBS Weekend this Fall is being discussed. It will likely be held in early October, with the hopes of holding VBS in person. The BOCE would like to work with the Technology Committee to purchase a new projector (and potentially a screen) to be used by the Congregation, Sunday School teachers, and also for VBS. The BOCE will be looking for a full slate of new members for the upcoming year.

EARLY CHILDHOOD ED. - Karen Niederjohn

Fall enrollment currently has 10 openings. There are two lead teaching positions open. Need to hire 2-4 afternoon staff to cover

open shifts. PT and Annette will social distance to have a modified chapel with each age group. PT broadcast bible stories at nap time to each room in May. This may continue occasionally as necessary. TLCLC is proceeding with summer curriculum. The BOECE had meetings with Annette every Tuesday in May for 20-30 minutes to discuss issues related to Re-Opening of TLCLC. Variance requested to use school age playground for more space during COVID-19. No response from licensing. May request again if need for Fall. Asking for variance to use Fellowship Hall kitchen during kitchen construction. Licensing responded that a variance was not required. TLCLC License expires 8/31/20. Paperwork will be submitted in June to renew. Kitchen flooring and cabinets have been installed. Countertops are on order. Bathroom partitions have been reordered.

TREASURER'S REPORT - James Harms

Mav's Church income was \$47,579 with a year-to-date income for the period ending May 31, 2020 at \$231,165 (42.66% of the years \$541,875 budgeted income). Greater than anticipated. May's Church expenditures was \$30,879 with a year-to-date expense total for the period ending May 31, 2020 at \$158,121 [35.23% of the years \$448,769 budgeted expenditures (\$541,875 budget -\$93,489) Pastor Contingency]. The Church's year-to-date fivemonth income over expenditures was \$73,044. This number is Pastor Contingency is deducted. May's Learning Center income was \$20,255 with a year-to-date income for the period ending May 31, 2020 at \$196,385 (26.83% of the years \$732,000 budgeted income). At the end of May TLCLC has a \$7,947.50 COVID-19 Tuition Credit Accounts Payable. May's Learning Center expenditures were \$62,986 with a year-to-date expense total for the period ending May 31, 2020 at \$257,182 (35.13% of the \$732,000 annual expenditure budget). Learning Center's year-to-date fivemonth income over expenditures was a negative (\$60,797). Combined (Church and Learning Center) income over budgeted expenditures totaled \$12,247. This amount is reduced to a negative (\$31,425) after \$43,672 was paid in BOD & AOV Expenditures. Net operating cash available has been reduced to \$112,937. COVID-19 and AOV/BOV Motions/Approvals has greatly reduced the church's available cash to cover its day to day operations. At the end of May \$31,647 is available in the checking account when you exclude \$125 Petty Cash and \$81,165 of Money

Market Reserves. On April 14, Trinity received a \$109,500 SBA Paycheck Protection Program (PPP) forgivable 1% loan. These funds to be used to retain workers and maintain payroll over an 8week period. If 75% of PPP funds are used for payroll costs, we are expecting the loan be forgiven. TLC must apply to the SBA for the loan to be forgiven. AOV approval required to utilize. May 31 Dedicated Accounts total \$187,765. This amount does not include the GSLS \$144,000 reserve at LCEF, but does include the \$109,500 PPP loan. May 31, 2020: Lutheran Church Extension Funds accounts total \$668,615. April 30, 2020 TLC LCMS Foundation Endowment Funds account value was \$94,412. A market reduction of (\$8,623) from the beginning of the year. Acct 995.1 TLC BOD/AOV App: \$2,111 expenses (\$1,318.20 - 4 Niederjohn, Carol Morrison, Larry McCoig, Pat Campbell, Laura wooden sanctuary chairs; \$408.87 - Lent lite supper; and \$384 -AOV meal) Jim Harms reported one correction. May 31 Dedicated Accounts total \$187,876, not \$187,765. Angel Arnall moved to approve the Treasurer's Report with this correction; seconded and approved.

OLD BUSINESS:

Audio / Visual Needs (Live Streaming) Chairman Kespohl appointed a committee of four to get bids for upgrades: Chris Kespohl, Kevin Mott, Benjamin Asbeck and Sean Huggans.

Wi-Fi Upgrade Bid See page 27-31 of the BOD packet for complete information. Larry McCoig moved to approve \$6,241.52 for Wi-Fi Upgrade; seconded. Larry McCoig amended his motion to say six months into the first year, we need to ask about a maintenance agreement going forward; amendment seconded and approved. Chairman Kespohl called for a vote on the amended motion; seconded and approved.

NEW BUSINESS:

Accepting Credit Card Contributions - James Harms Jim Harms reviewed the VANCO handout. Larry McCoig moved to stop accepting debit cards as a contribution method; seconded and approved. Angel Arnall moved to make this recommendation to the AOV, with the stipulation that this subject return to Stewardship & Finance for further research; seconded and approved.

Fellowship Hour (Informational) The Board of Evangelism decided the Sunday morning Fellowship Hour of coffee and donuts will be cancelled until the issues around the pandemic have been resolved.

For the month of May, the Regular Envelope collections are 113.62% of the anticipated monthly amount. Loose Plate collections are 125.83% and Sunday School are 0%. The Total Monthly collections are 113.62% of the monthly anticipated amount of \$38,823.91. The Total Year to Date collections through the end of May are 105.78% of the anticipated amount of \$199,532.72.

TREASURER'S REPORT: James Harms

May's Church income was \$47,579 with a year-to-date income for the period ending May 31, 2020 at \$231,165 (42.66% of the years \$541,875 budgeted income). Greater than anticipated. May's Church expenditures was \$30,879 with a year-to-date expense total for the period ending May 31, 2020 at \$158,121 [35.23% of the years \$448,769 budgeted expenditures (\$541,875 budget \$93,489) Pastor Contingency]. The Church's year-to-date fivemonth income over expenditures was \$73,044. This number is reduced to \$34,090 when the budgeted portion of the \$93,489 Pastor Contingency is deducted. May's Learning Center income was \$20,255 with a year-to-date income for the period ending May 31, 2020 at \$196,385 (26.83% of the years \$732,000 budgeted income). At the end of May TLCLC has a \$7,947.50 COVID-19 Tuition Credit Accounts Payable. May's Learning Center expenditures were \$62,986 with a year-to-date expense total for the period ending May 31, 2020 at \$257,182 (35.13% of the \$732,000 annual expenditure budget). Learning Center's year-to-date fivemonth income over expenditures was a negative (\$60,797). Combined (Church and Learning Center) income over budgeted expenditures totaled \$12,247. This amount is reduced to a negative (\$31,425) after \$43,672 was paid in BOD & AOV Expenditures. Net operating cash available has been reduced to \$112,937. COVID-19 and AOV/BOV Motions/Approvals has greatly reduced the church's available cash to cover its day to day operations. At the end of May \$31,647 is available in the checking account when you exclude \$125 Petty Cash and \$81,165 of Money Market Reserves. On April 14, Trinity received a \$109,500 SBA Paycheck Protection Program (PPP) forgivable 1% loan. These funds to be used to retain workers and maintain payroll over an 8week period. If 75% of PPP funds are used for payroll costs, we are expecting the loan be forgiven. TLC must apply to the SBA for the loan to be forgiven. AOV approval required to utilize. May 31 Dedicated Accounts total \$187,765. This amount does not include the GSLS \$144,000 reserve at LCEF, but does include the \$109,500 PPP loan. May 31, 2020: Lutheran Church Extension Funds accounts total \$668,615. April 30, 2020 TLC LCMS Foundation Endowment Funds account value was \$94,412. A market reduction of (\$8,623) from the beginning of the year. Acct 995.1 TLC BOD/AOV App: \$2,111 expenses (\$1,318.20 - 4 wooden sanctuary chairs; \$408.87 - Lent lite supper; and \$384 -AOV meal) Ron Barrett moved to approve the Treasurer's Report; seconded and approved.

TLC agrees to pay \$4800 for the design of the TLC website and \$3200 for the design of the TLCLC website. TLC further agrees to pay (RPM) \$2000 per year for the maintenance of the two websites." John Frerking moved to approve the BOD's recommendation; seconded. Discussion.
