

On Monday mornings at 9 a.m. Pastor Thieme is teaching a series on A Martyr's Faith in a Faithless World by Bryan Wolfmueller.

Christians need heroes. Christians need heroes like David and Paul, who remind us the Lord can forgive murder, adultery,

March 14, 2023 Board of Directors (draft meeting minutes)

- Opening Devotion & Prayer: The meeting started at 6:30 pm. Pastor McCalley led the board members in singing Stanzas 1-2 of Hymn # 604, I Bind unto Myself Today, hymn written by St. Patrick.
- II. Attendance: Larry McCoig (President), Warren Harms (Treasurer), Mary Frerking (Secretary), Dan Watts (BOECE), Annette Kiehne (TLCLC Director), Jensen Duenckel (Stewardship & Finance), Gary Frisch (Endowment), Doug McDowell (Trustees), Jacque Eckhoff (Youth), Daniel Hakes (BOCE), Pastor Thieme, Pastor McCalley & Karen Harms.
- III. Approval of the Meeting Agenda: The President noted an addition to the Agenda under New Business for the "Board of the Month" report by the Board of Early Childhood. Motion was made and seconded to approve the agenda as amended. Motion approved without further discussion.
- IV. Treasurer's Reports: The Treasurer reviewed the submitted reports. These first four accounts are available for building funds for a total of \$585K. This money could be used towards the building plan, if approved. Page 5 of Annual Report (44.9% for the year. \$1100 of the expense was the cost of copies from the last quarter from 2022. It is a high % but not a big concern. May potentially need to be adjusted in next year's budget. The TLCLC Director reported the costs of the current training for employees were paid out of the budget rather than the new grant. On the first Friday in March, TLC received @\$5K for a technical grant. Motion to approve the Treasurer's reports was made, seconded, and approved without further discussion.
- V. Approval of the Consent Agenda: Motion was made and seconded to approve the Consent Agenda. Trustees requested to expand on their submitted report. Motion was made and seconded to approve pulling out the Trustees report. Agenda approved without further discussion.

Trustees reported obtaining bids on 2 half doors and two solid doors for the Learning Center. The TLCLC Director reported on which doors are planned to be replaced in the LC. The Trustees are also going to look in to having insulation blown into the space between Pastor McCalley's office and the nearest Learning Center classroom to reduce sound. Having no carpet in the classrooms contributes to the sound issue. Trustees also plan to have dollar numbers to present at the Special AOV meeting in terms of other costs for the building, in addition to an asphalt overlay for the church parking lot.

- A. Proposed By-Laws Changes: The BOD has received some proposed changes. When all responses are received, the President will then appoint a Constitution committee to review. The BOD will not review the proposed changes this evening. Anyone interested in serving on the committee to review the By-Laws changes should let the President know.
- B. Church Worker Scholarship: Submitted by Josiah Thieme a request for a scholarship. Motion was made and seconded to approve the scholarship request. Line 617 of the budget has a balance of \$4K available for scholarship requests. The requirements for the scholarship were handed out at a prior BOD meeting. If approved, it could be paid out at the beginning of each semester. The reserve account is #195. Motion was made for the 2023-2024 academic year to approve the \$4K scholarship for Josiah Thieme. The motion was approved without further discussion.

Intermissio: Pastor McCalley led the board members in singing Stanzas 3&4 of Hymn #604.

VII. New Business:

- A. Bus Use Request: Pastor McCalley: Pastor McCally reported on the Tallis Scholars Concert on 4/19 and members would like to use the bus for the trip. Motion made and seconded to approve the motion, contingent on a driver being available. It was reported that a driver should be available for the trip. Motion approved without further discussion.
- B. Board of the Month: BOCE: The Chair of the BOCE reported on Sunday school each week, which includes activities and lessons, followed by Arts & Crafts and a snack at the end. The Chair also reported on other activities for the children of the Congregation throughout the year. Three goals of BOCE for 2023: 1). Collaborate with the Board of Evangelism, specifically reaching families in the homes nearby; 2). Advertise more effectively for VBS this summer (currently June 6 9; and 3). Seek new ways to reach out and tell people about Jesus.

March 19, 2023 Special Assembly of Voters (draft meeting minutes)

Meeting was called to order at 12 noon.

- I. **Opening Devotion**: Pastor Thieme led the voters in an opening devotion from Psalm 134.
- II. Attendance Roster: See attached Attendance Roster. 62 members signed the Attendance Roster.
- III. Request a 30th Anniversary Committee Approval to oversee and execute the celebration:

A motion was made by Debbie Antel to appoint an Anniversary Planning Committee to oversee a celebration of the 30-year anniversary of the ordination and installation into the Office of the Holy Ministry of the Rev. Brian Thieme. Motion seconded.

The committee shall have full scope of authority to make all plans, decisions, and expend funds (budget and contributions).

The committee shall have three members and additional members to sub-committees, all recruited and appointed by the President of the Congregation. Debbie Antel (chair), Chris Cott and Larry Samuel shall serve as committee members. The Rev. Joseph McCalley shall serve as Advisory member to the committee. President Larry McCoig shall serve as Ex Officio Member to the committee.

The Committee shall report at each Regular 2023 AOV meeting, with a final report at the December 2023 AOV meeting.

Motion approved without further discussion.

- IV. Treasurer's Report from 12/31/2022: The Treasurer's report is included in the packet, but he was unable to attend the voters meeting. Motion made and seconded to accept the Treasurer's reports. No questions were offered by the church voters. Motion approved without further discussion.
- V. Financial Committee Presentation: No one from the Financial Committee was present at the voter's meeting. No motion was required with respect to the report. The floor was opened for questions from the voters. The President noted the report states \$412,000 cash to be used towards any project the voters' desire. A question was raised about the \$486K noted from the earlier survey from the financial committee. No funds were collected as part of the Survey. The President reiterated the report notes \$412K cash. Question was raised to look into the cost to repair the lift on the bus.
- V. **Trustees Presentation on Premises**: Handout was provided to the voters at the meeting. Trustees offered information about long term expenses. A 2-inch overlay front and back is \$160K for both parking lots. Trustees reported that if you keep the surface sealed it will last longer, but it is an expense in the future sometime. Crum did a survey of all the furnaces and A/C units on the building premises. Found one AC unit from the LC which is a \$4K unit and can be taken care of under regular maintenance. Also had a meeting with Septagon re the expansion of the kitchen. Trustees also spoke to Septagon on the phone, and their "ballpark guess" for kitchen repairs is b/t \$150-160K (new floors, cabinets, appliances, etc.).

Comment made from a former Trustee about his

discussion with Crum when he was a Trustee several years ago concerning the cost of replacing all furnaces (new in 1982). The first estimate 4 years ago was \$60K, and probably approaching \$80 to \$100 K now. It has been 30 years on this set of furnaces, and he expects an expense of \$100K in the future.

Question raised about expanding the walls of the kitchen and the cost includes that expansion.

Question also raised if we need a new sewer system from kitchen to outside. It was discussed with the rep from Septagon and is included in the estimates for the kitchen.

Question raised about expecting any large termite issue in the LC. Trustees has checked for termites, and they are being treated and will have an annual treatment. As for current damage, Trustees reported on the resolution and repair of the termite damage noted in the LC. In addition, the termite rep looked and determined they had not gone any further. Part of the office and classroom will be taken out and studs taken out and dry wall repaired. The terminate rep conducted a total survey of the church property and could not find any other damage any where else in the building.

VI. Building Committee Presentation: (Note: Minutes were taken for this portion of the meeting by Debbie Harms, and transcribed by Mary Frerking).

Motion as presented in the AOV Packet was made by the Building Committee and seconded. Discussion followed.

A representative from the BC made a brief presentation. The BC was formed in 2019 after the Visioning Committee met with members on the wants & needs of the congregation. BC's first project was the doors/access to the Fellowship Hall. Received \$90K in approved funds to complete the project. Spent \$84,400.

In 6/2022, BC asked voters for approval of \$220K to retain an architect to work on preliminary designs for accessibility for the church, The BC retained SOA Architecture to review the wants and needs of the church and to put together preliminary designs for this building project.

It was estimated at that time costs for this project could range from \$2.6 million to \$3.8 million. BC has had numerous meetings both with and without the architect to review the preliminary designs and identify what was needed for the project, what was not needed and what could potentially be deferred to a later date (i.e., Canopy over front drive, sprinklers in gym and Learning Center, etc.).

Handouts were provided from the BC – a Total

Cost Update, main and lower-level floor plans and colored copies of the preliminary designs put together by the architect.

At a 2/7/2023 meeting with Pastor Kennaugh from LCEF, the President of the congregation, chair of the BC, three other members of the BC and a Trustees met to discuss how to go forward with a church building project. The BC was advised it should first obtain approval from the voters for the plan and then, if approved, move towards raising the funds to complete the project.

Further discussion followed. One member provided a handout to the voters setting out reasons the building plan should not be approved and also asked what were the priorities of the BC when putting forth these plan. BC explained accessibility/mobility is the primary issue identified by the voters when looking at the building needs of the congregation. Communication was the second issue identified by church members.

Comment was made that sprinklers in the LC should be a priority.

A voter requested clarification on the final two numbers on the Total Cost Update. These numbers were explained by the BC. BC also explained there are 3 buildings to the church property, all separated by fire walls. If you update one of the three buildings, that building will need to have sprinklers installed to bring it up to Code.

Another member addressed what he identified were irregularities in the process. The BC was asking for approval of the plans only and not the cost of those plans. The member also asked the voters to think why we need to commit to only one project. Rather, voters should be offered more than one project/plan on which to vote.

BC explained the vote is to determine what the congregation wants to do, not what the BC wants to do. This is a recommendation from the BC, but it is the voters' final decision. If the project is approved, the next step will be to raise the funds. Nothing will be spent without the voters' approval.

A question was asked if the plans as presented are not approved an the plans be revised to fit the budget. The answer was yes.

BC further explained that today the motion from the BC is to approve the building plan only. Members of the congregation need to know what the plan is so if they want to contribute to the church, they will know what they are contributing to. The President also advised all members are welcome to attend BOD meetings and the AOV in November when budget items are discussed.

A comment was made by a church member that the voters should consider the mission of the church, and that the voters should be offered competing plans to consider before asking for approval.

Another member complimented the BC on all of their work but advised he would not be voting for approval of the plan. First, he is not convinced it improves the ministry of the church. Second, he believes the \$2.14 million addresses more of the wants rather than the needs of the church. Third, the congregation should not go into debt, but rather only vote for what we as a church can support financially.

Comments were also made that we need a good elevator and stairs. Another stated the plan as proposed offered too much and was beyond what was needed at the church. Another member stated we should look towards the future and bring our church out of the 1960's.

One member stated he is aware of \$700K that current members would commit to the building plan, which would be in addition to the \$412,000 is available savings.

Then a member of the voters called for a vote. The call for a vote must be approved by 2/3 of the members in attendance at the meeting. A show of hands was called for by the President to approve the call for a vote. The President counted the hands and the 2/3 threshold was met.

The Building Committee restated the motion to the voters. Handwritten ballots were distributed to the voters. Ballots asked for a "yes" vote to approve the motion, or a "no" vote to not approve the motion. Two Elders in attendance collected the ballots and tabulated the results. Each of the elders separately counted the ballots. (Handwritten ballots were retained after the meeting).

"Yes" votes: 35:

"No" votes: 21.

"Abstention": 2.

Submitted no voting ballot: 4.

Total voters in attendance: 62.

Motion passed.

VII. Announcements:

 The next BOD meeting will be held on April 11, ◆ 2023, at 6:30 pm.

When Oregon's Measure 16 passed, assisted suicide was limited to state residents. That requirement was recently deemed inoperative by the state's everflaccid suicide regulators after a lawsuit was settled and is expected to soon be repealed. That threatens to open a floodgate and transform Oregon into the U.S. equivalent of Switzerland, where suicide clinics flourish. Already, people from out of state who have been diagnosed with a terminal illness—something very loosely defined—are traveling to Oregon to find a death doctor willing to help them make themselves dead in just over two weeks. From the Daily Mail story:

"Oregon has become America's first 'death tourism' destination, where terminally ill people from Texas and other states that have outlawed assisted suicide have started travelling to get their hands on a deadly cocktail of drugs to end their lives, DailyMail.com can reveal. In the liberal bastion Portland, at least one clinic has started receiving out-of-staters who have less than six months to live and meet the other strict requirements of the state's Death with Dignity (DWD) law. Dr Nicholas Gideonse, the director of End of Life Choices Oregon, recently told a panel that he was advising terminally ill non-residents on travelling to Oregon to end their lives, despite a legal gray area." (National Review, Daily Mail, 2/5/23)
