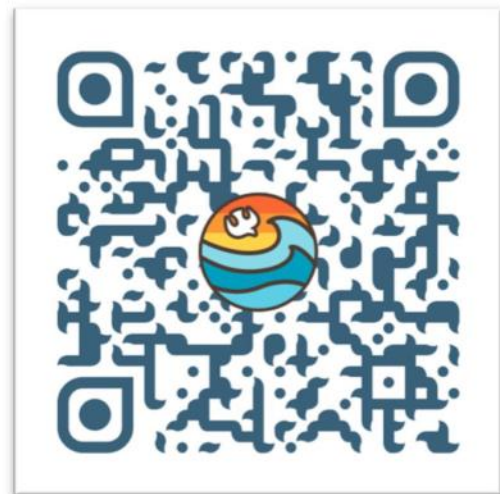

#### **XIV. New Business:**

Information Only: Elders advised the worship schedule for Sunday, September 10, 2023, will be revised to provide for a single, combined service at 10 am with Holy Communion, and to approve the invitation and expenditures for the Rev. Randy Asbury to serve as Guest Preacher for the event, including honorarium, mileage, and hotel (if needed).
- B. Information Only - Elders advised that the travel expenses for the Rev. Dr. Lee R. Hagen, District President LCMS Missouri District to attend and serve as assisting minister: The Chair of the Board of Elders reviewed Items A&B above for the voters in attendance. There were no questions from the voters in attendance.
- C. Trinity Lutheran Child Learning Center-Motion to approve the purchase the items/projects to expend funds as outlined to meet the needs of TLCLC- and according to the requirements of the DESE grants. Funds not used within the needed timeframes will be transferred to the reserve account (See Revised Handout).

The motion stated above was made and seconded. Discussion followed. The chair of the BOECE reviewed parts of the POA. These funds are grant monies from the State of Missouri and were part of package through the Cares Act in the middle of Covid and were followed by the American Rescue Plan to assist child learning centers throughout the state.

At end of May of 2022, the voters approved the initial application for the funding available. Item no 3, the DESE PPP are for Rounds 2&3. The TLCLC has already received the funds for Round 1. These are new funds.

The TLCLC is asking for approval to run the business and expend the funds as directed by and set forth in the POA.

Question: How many times can a tax-exempt entity accept funds and not be asked to do what we do not want to do?

Once funds are received, TLCLC will be limited to spending the funds as directed by the state and for the benefit of the TLCLC. The Chair reported there is no distinction for the usage of these funds. We know there is a distinction between church and secular entities, but do not have any idea what if any control the government could exert on the TLCLC.

The Director advised that license-exempt religious

organizations can apply for this grant and this stated concern should not be a concern.

The Chair of the Bd of Elders noted TLCLC will need to account for the spending of these funds. If there is no language in the grant offering now, they cannot enforce control in arears. It would have to be in the grant offering at the time.

Noted in No. 8, the TLCLC has a time frame for all their projects and for all grant money that comes in. As the money is spent, the money goes down, but will not just sit there. Rather it will be moved to a TLCLC Reserve Account. There are some grants that give you a time frame to spend the \$\$ or return it to the government. Some grants have no timeframe limitations. Our time frame is to use the money for the TLCLC's mission.

Q: Are we setting ourselves up for a governmental audit? Are we going to have to prove how it was spent? Yes, but the grants are not that specific, and the TLCLC keeps good accounting of how much it spends and what it will be spent on. It was also noted that the church's records are in very good shape, and an audit would not be a problem whatsoever.

The motion as set forth in the AOV packet was approved with two voters opposed. Motion was approved.

- D. Benefits Committee Plan of Action: Item No. 5 on the handout is the Motion. A representative of the BC asked the Congregation to approve the POA that began in 2022 and has passed the BOD as presented on page 31 of the Packet. The motion was seconded. The Chair reported that the BOD reviewed the motion and approved it unanimously. Discussion followed. The motion was approved without further discussion and without opposition.
- E. 30th Anniversary Planning Committee Report (See Handout) – For Information Only. No questions were offered to the Committee rep in attendance.

**Dear Christian friends who value every life God creates, redeems and sanctifies,**

Fifty three people enjoyed Christian fellowship, excellent speakers and good food at Trinity Lutheran Church on May 6th for the Annual Meeting of Lutherans For Life of Missouri. Pastor Joseph McCalley began by addressing the question "How do we die well?" and offered an excellent resource called "Death, Life, and the Resurrection: Resources for Devotion and Caregiving. Pastor Scott Licht, CFO/COO of the national office of Lutherans For Life spoke about many of the "End of Life Considerations" to include documents, powers of attorney for health care, curative and palliative care, hospice care, caregiving and how to help caregivers. It was a memorable event.

Valuing people at the end of life goes hand in hand with valuing those at the beginning of life, especially the unborn. Some may be tempted to think that since "Roe v. Wade" was overturned a year ago, abortion is no longer an issue. However, see what Pastor Michael Salemink, the executive director of Lutherans For Life, has to say about the importance of continuing to speak the truth in love to a hurting world.

### **Moving Ahead!**

After Dobbs, there is celebration and rejoicing. The Supreme Court vacated Roe v. Wade's mandatory abortion access framework. Gospel-motivated voices For Life have prevailed with God's truth and Christ's love. The population is paying attention to the sanctity of life. Abortions are decreasing in several jurisdictions and ceasing entirely in some states.

After Dobbs, abortions will continue. Certain locations are doubling down and expanding funding and facilities for it. Women and men still experience surprise pregnancies. "Pill" or "medication" abortion chemicals are becoming available online, across borders, and at neighborhood pharmacies with minimal supervision, if any.

After Dobbs, misinformation is multiplying. Preserving women's lives during pregnancy complications rarely, if ever, requires abortion. New restrictions do not affect care for miscarriages and ectopic pregnancies. Science does not classify embryos as parasites and has no dispute about when human life begins. Scripture does not approve of or allow for abortions. Christians delight to assist and support after childbirth. And pregnancy resource centers do not mislead or manipulate.

After Dobbs, dangerous measures and mindsets remain. Popular rhetoric is pushing acceptance of physician-assisted suicide and euthanasia. Mass media and universities are undermining biblical sexuality and biological gender. Genetic engineering research and procedures produce embryos for mutilation. In vitro fertilization and surrogacy receive widespread praise without regulations or reflections upon children's welfare. Intrauterine devices and hormonal contraceptives can end lives before implantation.

After Dobbs, neighbors need healing. Hearts and bodies have been broken by the abortion of their own children. Many secretly suffer guilt and silently struggle with grief. Grace and forgiveness cherish their lives as precious as the ones that were lost.

**After Dobbs, our message and ministry matter more than ever.** The scabs have come off, and the time has arrived for diagnosis and remedy, relief and prevention. The land is listening, so let us speak truth with courage. The world is watching, so let us show love and compassion. Abortion has only ever represented a symptom. The sickness has always consisted of the deeper reality of sin. So, law never embodied the finish line or the prize. Our Savior's victory invites us to settle for nothing less than sharing life, abundant and everlasting, with each human being and receiving them all as gift and privilege.
