The word "surprise" does not match what I experienced in that day's celebration, but also the trip you chose for Sarah and me to enjoy. Dear Friends of life,

If you are wondering "what now?" since *Roe v. Wade* was struck down, the new president of Lutherans For Life, Diane Albers, has a message for you. A lot is going on in the state legislatures and there are many attempts to change constitutions to include the 'right' to an abortion. Now is the time to get informed and stay vigilant. Here is Diane's message:

A Year since Dobbs

by Diane Albers, President of Lutherans For Life

We've just passed the one-year anniversary of the *Dobbs* decision which overturned *Roe* and sent the abortion debate back to the states. *Dobbs* was certainly great news, but we haven't yet reached our end goal—making abortion unthinkable.

Open your mouth for the mute, for the rights of all who are destitute. Open your mouth, judge righteously, defend the rights of the poor and needy. Proverbs 31: 8-9

Notice in those two verses God asks us twice to open our mouths for those who cannot speak for themselves. But we cannot just open our mouths. We need to be prepared to speak the truth in love, to give facts and fight misinformation and outright lies from the other side. Check the status of abortion in your state. Make sure you aren't taken in by false narratives. Most prolife politics have shifted to the states. Pro-abortion groups are throwing tons of money at ballot initiatives. *Think Michigan and Kansas.*

What happens when you do a search for "crisis pregnancy centers"? The first thing that often appears is from American Congress of Obstetrics and Gynecologists (ACOG), which begins with a good explanation of what the center does. However, the article goes on to warn against CPC facilities. Why? The article reiterates that CPCs claim that they are legitimate health care clinics for "pregnant people," but in reality they are trying to prevent abortion with their antiabortion agenda, use "misleading" practices by CPC staff, and spread misinformation about "so-called abortion 'reversal.'"

Many of you work with a CPC. We know what they do to help women who are pregnant, their babies, and their partners as well. Most of these centers operate based on Christian principles. The CPCs, and we in Lutherans For Life, know that these women need the love of Christ. *And we know most believe it is wrong to kill their baby.*

This spring at the March to the Arch in St. Louis, there were opponents with megaphones trying to disrupt the march. They screamed slogans the entire way, not listening to any counterarguments. My friend observed, "They don't have anything to back up their beliefs, so they just shout louder."

We have the grace and truth of the Gospel to share—not only with women and men in crisis pregnancies but with those so adamantly advocating for abortion. Why would we *not* share Christ with a lost and hurting people? LFL has a lot of information available to you on the website and through brochures and tracts. Check it out!

September 24, 2023 Assembly of Voters (draft meeting minutes)

The Meeting was called to order at 12 noon, and a quorum was present.

- I. **Opening Devotion:** Pastor McCalley led the members in singing the first 5 stanzas of Hymn 555, *Salvation Unto Us Has Come*.
- II. **Introduction of first-time attendees to the Assembly of Voters:** Several members were first time attendees to an AOV meeting. Mike and Jenny Brame are transfers to the Congregation. Nancy Shinrock and her husband Fred recently joined the Congregation by profession of faith. Fred passed away in early August. Timothy Smith has been coming to TLC for about 18 months. Kevin and Mary Lou Hughes have been members for about 6 months. A motion was made and seconded to accept these individuals as new attendees to the Assembly of Voters.
- III. **Attendance Roster:** Members signed in on the Attendance Roster for the meeting.
- IV. **Addition of items to the Agenda:** The President noted one addition to the agenda under New Business – a Bus Use Request.
- V. **Approval of Agenda:** A Motion was made and seconded to approve the AOV meeting agenda as revised. The motion was approved without further discussion.
- VI. **Approval of the Assembly of Voters minutes** - May 21, 2023, Assembly of Voters Meeting. A motion was made and seconded to approve the Minutes from the 5/21/2023 AOV meeting. The motion was approved without further discussion.
- VII. **Pastors' report:** There were no additions or changes to the Pastors' reports as submitted.

- IX. **Financial Secretary's Report** from September 12, 2023, BOD meeting: The Financial Secretary reviewed her report included in the packet. No questions were made by the members in attendance. A motion was made and seconded to approve the report as submitted. The motion was approved without further discussion.
- X. **Treasurer's Reports** from September 12, 2023, BOD meeting: The Treasurer reviewed his reports included in the packet. It is noted through August we are blessed to have a surplus in funds. It was also noted the church's expenses in Administration are over budget due to the office having to replace a couple of computers, which was unexpected. The copier expenses are also over budget and will continue to increase. Fellowship Hour is over budget as well, and he is not sure why. Total church and Learning Center budgets are 63.99%, which is pretty much on track for the total budget for the year.

DESE (Department of Elementary and Secondary Education) Grants: Checking account had \$388K, and of that amount, \$322K of that is for DESE Grants, which are grants from the State of Missouri. These grants will be spent over the next few years. The Governor has given money to childcare facilities in the State of Missouri, including TLCLC.

Trustees asked if DESE grant money could be used towards the repair of the footings under the Learning Center portion of the church building. The President advised that some grants required

that each request set forth how the money was to be used. Any excess \$\$ from the grants is to go back to the Learning Center.

A motion was made and seconded to accept the Treasurer's reports. The motion was approved without further discussion.

XI. **Board Reports:** (Supplement to the reports included in the packet):

Trustees: The Trustees expanded on their report regarding the foundation needs on the East side of the church building under the Learning Center. A handout was provided to the members and reviewed by the Trustees concerning a Plan of Action to stabilize the foundation.

The Trustees presented a motion to approve up to \$40K to use for foundation repair, with the final decision for awarding the bid to be made by the Trustees after they have had an informational meeting before 10/6/2023 and approved by the BOD at the 10/10/2023 BOD meeting. Discussion followed.

The foundation has dropped, they believe, close to 3 inches.

The Trustees will offer tours to any members that wish to see the cracks and other visual examples of the drop in foundation. A question was raised if the \$40K would cover any additional repairs that will need to be made, such as cracks in the drywall, mudding, painting. Trustees indicated those repairs could be covered by the Trustees' budget. The sidewalk replacement will be made by one of the two companies chosen to make the repairs.

It was also asked if this foundation issue was related to the sinking problem in the Learning Center a few years ago. Trustees indicated that previously there was a slab separation in the north part of the Learning Center. Pro Foundation Technologies jacked up the slab and lifted it and provided the church with a 5-year warranty. It has been redone once already. Trustees noted the previous issue concerned only the north slab and not the east wall and the foundation footings.

It was suggested that Trustees also check for termites on the east side of the building (a check was already made on the west side of the building), which may be an additional problem that will need to be resolved. Additional funds may be required to take care of potential termites.

The Trustees will compare the two companies' proposals, including their potential warranties offered for their work.

A motion was made and seconded to approve

the Trustees' Plan of Action. The motion was approved without further discussion.

XII. **Miscellaneous Reports:** (For Information Only):

Two reports were included in the packet provided to members for their review: A Stephen's Ministry Report and a 30th Anniversary Committee Report.

XIII. **Old Business:** None

XIV. **New Business:**

A. Financial Review Committee – Slate of candidates (Handout): The Financial Review Committee is a Standing Committee with new members each year. The slate of candidates is set forth in the handout. The committee will be asked to review financials for 2022. A motion was made and seconded to approve the slate of committee members. The motion was approved without discussion.

B. Bus Use Request: A motion was made and seconded to permit the use the TLC bus on 12/1 and 12/2 for the Meet Me at the Manger event being held again this year at Campus Lutheran. Discussion followed. Mr. Gary Kespohl will drive the bus for the event and Campus Lutheran will pay for fuel. A question was raised if this agenda item should have been reviewed by the BOD rather than the AOV. The motion was approved without further discussion.

XV. **Announcements**

A. The next BOD Meeting will be on October 10, 2023, at 6:30 pm.

B. The next regularly scheduled AOV meeting will be November 19, 2023, at 12:00 pm, and will address only the Nominating Committee and the Budget.

XVI. **Adjournment:** A motion was made and seconded to adjourn the meeting. The motion was approved. The meeting was adjourned at 12:52 pm.

XVII. **Closing Devotion & Prayer:** Pastor McCalley led the members in singing the last 5 stanzas of Hymn 555.

- III. **Approval of the Meeting Agenda:** Pres McCoig asked to add Item D to New Business to discuss 1 service on November 5, 2023 (All Saints Day) at 9:00 am. A motion was made and seconded to approve the meeting agenda as amended. The meeting agenda was amended and approved without further discussion.
- IV. **Treasurer's Reports:** The treasurer reviewed the reports on pages 3-8 of the agenda pack. Through September 75% of the fiscal year is complete. Church income is \$494,360 with expenses of \$397,746. The Learning Center income is \$735,819 with \$775,279 expenses. September included a third payroll period of approximately \$30,000 and the workers compensation insurance audit expense of \$4,659 causing the month of September for TLCLC to be a deficit. Two emails on pages 16-17 indicate more grant money from the State of Missouri has been applied for to affect the salary expense in 2023. A motion was made and seconded to place the treasurer reports and emails on pages 16-17 on file as presented.
- V. **Approval of the Consent Agenda:** A motion was made and seconded to accept the consent agenda as presented. The motion passed.

VI. **Old Business:**

- A. Report from the Board of the Month: Jacque Eckhoff reviewed a handout of activities of the Board and the Youth. David Atteberry of the Board of Elders emphasized just how important the work of the Board of Youth is to bring our young people together and keep them interested in the church.
- B. The Constitution Committee represented by Buck Kaat reviewed pages 23-of the agenda pack. Significant changes suggested to make are for the operation of Trinity's three Endowment Fund accounts. The current constitution and by-laws do not allow for use of any of the money.

The committee suggests an addition of Appendix A Rules if the Board of Trinity Lutheran Church Endowment Fund be added to the by-laws of the constitution.

Miscellaneous Changes to be made are that any items that are to make up an agenda item to be voted on for an Assembly of Voters meeting be published at least 2 weeks in advance in the church bulletin, monthly newsletter, or other such communication to members prior to the meeting.

An emphasis was made on what makes up a Quorum for an Assembly of Voters meeting. Twenty voting members are to be present before any business is discussed and if the attendance of voting members drops below twenty during the meeting business shall be ceased. The last highlight discussed would be that the Board of Directors be allowed to approve up to \$10,000 for expenditures rather than the current \$5,000.

The committee asks that the suggested revision of the by-laws of TLC be brought to the Assembly of Voters as written on pages 23 -33. President McCoig suggested that the BOD review these pages again and a motion be brought to the AOV at the regular AOV meeting in December.

VII. New Business:

- A. The kitchen committee included a report and POA motion to the BOD on pages 34-35 of the agenda to approve approximately \$180 expense for shelving in the storage room off the kitchen in the Fellowship Hall. Motion passed.
- B. Renew Missionary Donation of \$1,000. As no handout is included, President McCoig suggested some research be done on this through the pastors and an appropriate amount be included in the 2024 budget to be presented in November.
- C. 100th Anniversary Committee. President McCoig asked that each board ask a member to serve on this committee in 2024. Intent is to budget \$10,000 in the 2024 budget for this celebration.
- D. One combined church service at 9:00 am on November 5, 2023 for All Saints Day. The board of social ministry has agreed to lead in meal planning but will need assistance in set-up in the gymnasium or Fellowship Hall.

VIII. Announcements:

- A. The next BOD meeting is scheduled for November 7, 2023 at 6:30 pm.
- B. The next regularly scheduled AOV meeting is November 19, 2023, at 12 noon. This meeting will address only the 2024 budget and the 2024 nominated slate of candidates.

IX. Adjournment:

Meeting was adjourned at 7:35 pm.

President Larry McCoig led the members in a closing prayer.
