Epiphany of Our Lord

We have journeyed with Mary, Joseph, and the angels ("Glory to God in the highest, and on earth peace among those with whom he is pleased!" – Luke 2:14). In the manger, we found the Son of Mary wrapped in swaddling clothes with the shepherds "glorifying and praising God for all they had heard and seen, as it had been told them" (Luke 2:20). Christmas has been celebrated and marked. The Christmas hymns have been sung.

Now, we enter the season of Epiphany. Epiphany comes from the Greek word ἐπιφάνεια, which means "appearance." Where we met the Son of Mary, now we journey through the appearances and revealing of the true Son of God. Who is this that the Wise men of the east come to worship? Each week, as we move toward Lent, the Son of God's nature becomes more evident.

From His baptism (Mark 1:4-11), we see Jesus is part of the Trinity and beginning His ministry (Mark 4:15 – "The time is fulfilled, and the kingdom of God is at hand; repent and believe in the gospel") to His Transfiguration, He continues to appear as the true Son of God for His people.

The verse for the Epiphany of Our Lord reminds us of the words of the Magi.

Alleluia. Where is he who has been born king of the Jews? For we saw his star when it rose and have come to worship him. Alleluia (verse).

He is the King of the Jews, but the Introit and the Gradual note that the Christ is for all nations. At one time in church history, the Celebration of Epiphany was a more prominent holiday because it was seen as a "gentile Christmas," where we, too, are included in the promise of a Redeemer and Savior.

I will cause your name to be remembered in all generations;
therefore nations will praise you forever and ever.
Your throne, O God, is forever and ever. The scepter of your kingdom is a
scepter of uprightness;
you have loved righteousness and hated wickedness.
Therefore God, your God, has anointed you with the oil of gladness
beyond your companions;
your robes are all fragrant with myrrh and aloes and cassia (Introit).

Praise the LORD, all nations!
Extol him, all peoples!
For great is his steadfast love toward us,
and the faithfulness of the LORD endures forever.
Ascribe to the LORD the glory due his name;
bring an offering, and come into his courts! (Gradual).

The chair of the BOECE reviewed the Board's handout – Grant Fund Opportunities - for the members in attendance. It is noted none of the listed

numbers under Planning are definite, but estimates.

General Provisions are a summary of the rules that apply to the grants. The Grant Period is not a timeframe within which the grant monies should be spent. A question was raised under Provisions, #3 whether any funds are used for this amount. It was explained these monies were not used to reimburse anyone's tuition b/c TLCLC operates on a balanced budget. These monies are used to avoid raising tuition to a greater amount by supplementing tuition with these funds. The assistance is to all who attend the LC.

The Planning for these grant monies is to become tuition dependent again. These monies have been a blessing to the LC in many ways, including being able to provide bonuses to its employees. It is anticipated the church members may ask if there will be an audit and if there is any condition on the church if we receive these monies.

Grief Resource Available

Stephen Ministry has a resource available to you. *Journeying through Grief* book sets can help you extend care and minister to people you know who are grieving the loss of a loved one. The four short books are intended to be given at 3 weeks, 3 months, 6 months, and 11 months during the first year after a loss. A tracking card is included to record when each book is due to be given and the date they were given. Each 44-page book focuses on the feelings and issues a person is likely to experience at that point in his or her grief, offering comfort, help, and hope throughout that difficult first year.

Although the books are written from a Christian perspective, they address spiritual matters sensitively, with a focus on ideas and principles that would apply for any reader, whatever his or her beliefs.

It is sometimes difficult to know how to minister to others who are grieving. Our hope is this will be a loving and effective way for you to extend care to people in your life. The book sets are available to you at no cost or obligation. A sample set is on display in the information stand in the narthex.
