#### Pastor's Report

Dear beloved members and friends,

The book of Hebrews in the Bible has been associated with Paul. Yet, scholars believe it is unlikely that Paul wrote it. The thought patterns and the worldview of Hebrews are very different from the letters we know Paul wrote i.e.Romans, I and 2 Corinthians, Galatians, Ephesians etc. etc.

Near the end of Hebrews the writer tells his people "I appeal to you, brothers and sisters, bear with my word of encouragement." (13:22) They believe in Jesus Christ. Yet they still need encouragement. There is a concern that some members of the community have stopped coming together to pray. They have lost their fervor for ministry. At one time they threw themselves into service and worship, but now they are losing perspective and beginning to question the value of what they are doing.

Recognizing the drain on the community the author of Hebrews writes to encourage them. When I read this I think of today and the fact that many church communities even in our own day can become discouragement and fall into decline.

Our faith too can be threatened by many things: declining attendance in church, other Sunday morning temptations and obligations, arguments in the church, overextended families etc. etc.

I have observed that, in spite of some of these factors, you have not lost your faith. Although church attendance has declined, you have not lost your zeal for your church. The spirit among you is alive and well. I am excited every Sunday morning to worship with you:

two churches attended by members who dearly love their Lord and their church. In addition you do many things to serve your communities. So I want to say to you what the author of Hebrews says to his community:

"Keep on loving each other as brothers (and sisters). (13:1)

"And....since we are surrounded by such a great could of witnesses, let us throw off everything that hinders and the sin that so easily entangles, and let us run with perseverance the race set before us. And, let us fix our eyes on Jesus, the author and perfecter of our faith." (12:1-2)

Yes - that is exactly what I see all of you doing. Your eyes are "fixed on Jesus" - and I am happy and honored to serve you.

#### President's Report

For the second time in less than 5 years our congregation is in the process of calling a new pastor. This was the biggest challenge that we faced in 2018. It also opens the door for new and exciting times ahead.

While the call process can, and will, take a long time, this is also our opportunity to reflect on what our congregation stands for and what we want to accomplish in the future. Pastor Carol and Jodi Woessner worked hard on our Ministry Site Profile to make both Trinity and First look as appealing as possible to pastors that are looking for a new call.

If anyone is interested in serving on the Call Committee, please see me soon as the group will be able to get to work after we have submitted the Ministry Site Profile. We need a good mix of people involved in the process to make sure we select candidates that can meet our needs.

Financially the offerings in 2018 were down over 4.5% from 2017. We had prepared for this in the budget and were planning to take money from our Mission Plus account to help pay bills. Because we did not have a fulltime minister the last 4 months of the year, we were able to avoid taking that money and even grew our balance. We will need to continue our full offerings during this call process so we can build that balance higher and push back the amount of time after we hire a new pastor before we have to look at taking money from the Mission Plus account.

Besides finding a new pastor, our biggest challenge remains trying to increase weekly attendance. With increased attendance will come increased offerings, louder worship services, and new ideas.

I want to thank everyone for their hard work. Your efforts are appreciated by all of us. When something needs to get done, I always know that someone will step up and make it happen.
