Pastor's Report

"For in every way you have been enriched in him, in speech and knowledge of every kind—just as the testimony of Christ has been strengthened among you—⁷so that you are not lacking in any spiritual gift as you wait for the revealing of our Lord Jesus Christ." -1 Corinthians 1: 5-7

If we lack nothing, as the Scriptures say, why do we lack? Could it be that the problem is not God's failure to give, but our inability to receive?

It seems Paul understands our need for details, for particulars and proof that make us demand always more information yet leave us always feeling like we are still lacking something. Paul insists that as confessed believers gathered together "in Christ" we are already "lacking in nothing." Paul promises that we have at our disposal all that we could ever possibly need to live a life filled with hope and strength and grace.

We give thanks for the year 2023 with all of its gifts and challenges and we see a new year emerging before us. God has graced us with a superabundance of gifts. But we must be open to receiving them. We must be able to reach out our hands and accept what God would deposit in them, what God would put at our disposal and then be willing to use them.

"Our deepest fear," as Nelson Mandela said at his inauguration "is not that we are inadequate. Our deepest fear is that we are powerful beyond measure. It is our light, not our darkness, that most frightens us. We ask ourselves, 'Who am I to be brilliant, gorgeous, talented, fabulous?' Actually, who are you not to be? You are a child of God. Your playing small doesn't serve the world. There's nothing enlightened about shrinking so that other people won't feel insecure around you. We were born to make manifest the glory of God that is within us. It's not just in some of us. It's in everyone, and, as we let our light shine, we unconsciously give other people permission to do the same. As we are liberated from our own fear, our presence automatically liberates others."

"Lacking in nothing" means God intends our lives to be full, not flat; fluid, not stagnant; surprising, not dull. The promise that we will be "lacking in nothing" does not mean that we will be in total control at all times. Our first identity is as one who is "in Christ." Thus it is Christ to whom we give ultimate control over our lives. If you hold out your hands to Christ, prepare to be swung into action.

Let us commit ourselves in this New Year to serving more greatly, to giving more abundantly and to living more fully.
